#### **BASKETBALL CORRESPONDING DATES**

There have been several calls to the KHSAA regarding basketball scheduling for future years. Repeated below is the interpretation table which should be used for scheduling games for the next few years when comparing to 1998-99 playing dates. This has been published prior in the Commissioner's Notes and is repeated as a Q&A under Bylaw 25 in the 1998-99 Handbook. The week labeled "BK\*" is the "extra" week, and all other prior dates move forward when comparing to 1998-99.

Q/A - What are the corresponding dates for basketball for the next several seasons? School representatives scheduling basketball contests over the next several seasons can use the following comparative corresponding date chart to determine the applicable playing week of the season.

# FOOTBALL SCRIMMAGE-CAMPS CLARIFICATION

Q/A 8 - Do KHSAA scrimmage limits effect the participation of member schools in non contact simulations /passing leagues / pass skeleton drills against other schools during the period beginning July 15 and concluding with the first day of permissible full-contact practice?

Yes, with the following specific exceptions. Member school players and teams may participate in non contact simulations / passing leagues / pass skeleton drills during the period between July 15 and the first permissible day of full contact prior with the following restrictions, allowances and regulations --

1-May only wear the helmet of the equipment listed in Rule 1-5 of the National Federation Football Rules;

2-May be coached by the high school coach;

3-May not participate in this type of competition against members of another school squad on more than four dates during this period;

4-Must be completed with all play prior to the first legal day for contact by the varsity team (28 days prior to first regular scheduled contest);

5-May not participate with any more than seven (7) players from any one team at a given point in time.

<u>Q/A 9 What are the restrictions and allowances for member</u> <u>school football teams playing in team camps during the pre-</u> <u>season practice period (July 15 to the first day of the regular</u> <u>season)?</u> High school facilities and equipment may be used for summer football team camps at the discretion of the local school district. Football teams may attend/sponsor full contact camps during the period from the first allowable day of full-contact practice through the first legal playing date. All team camps held during this period must meet the following criteria -

1-A school may attend/sponsor only one camp during this period; 2-Each camp is limited to a maximum of three (3) consecutive days (not including days spent solely on transportation) of drills, skills assessment, competition or exercises which have any number of players from one school against any number of players from another school; or competition between students representing different schools;

3-Schools may participate in full scale scrimmaging (more than seven on seven) only on the last day of the camp, and only against schools who have attended the entire camp

4-Any properly conducted play between opponents from differing schools shall not count against the pre-season scrimmage limits in any sport.

5-Coaches must be paid members of the Kentucky High School Coaches Association to ensure the presence of liability insurance;

6-The school must ensure that each student athlete is properly insured in accordance with Bylaw 28 and eligible according to all KHSAA bylaws and regulations; and

7-The KHSAA Catastrophic Insurance Policy shall not be in effect and each school shall ensure that a policy similar to the KHSAA Catastrophic Policy and with the same policy limits is in place prior to the first day of the camp;

8-Medical staff and E.M.T. shall be notified of the camp and on call during the entire camp.

9-Member schools shall report attendance at these camps to the KHSAA on supplied forms prior to attendance or all competition between schools shall count against scrimmage limits.

# **BASEBALL - SOFTBALL TEAM PHOTOS DUE APRIL 30**

All baseball and softball team photos are due to the Association by April 30. Photos should be original prints and include a photo identification (front row: I to r). Schools are required to submit photos if they are competing in postseason play. If a school is not competing in postseason, photos are not required. Please note whether the softball team is slow or fast pitch.

#### STATE FAST PITCH SOFTBALL DATE CHANGE

Please note that the date for the 1999 KHSAA State Fast Pitch Softball Tournament at Panther Creek in Owensboro has changed. The 1999 event will now be played June 11-12. The event date is listed as June 10-11 on KHSAA Calendars and was changed after the printing of the calendars and recent additional consultation with the host site.

#### DEAD PERIOD

This reminder that the Dead Period for this school year is June 20-July 3, as printed in the KHSAA Memorandum Calendar. During this time, students may not receive coaching or training from school personnel (either salaried or non salaried) and school facilities, uniforms, nicknames, transportation or equipment shall not be used in any KHSAA sanctioned sport during the period beginning with the first day of National Federation Corresponding Week 51 (June 20), and going through the last day of National Federation Corresponding Week 52 (July 3). School funds may not be expended in support of interscholastic athletics in any KHSAA sanctioned sport during this period.

# 3-PERSON OFFICIATING TO BE USED IN 2000 POSTSEASON

The KHSAA Board of Control has approved and supports 3 person officiating for next year's (2000) boys' and girls' basketball postseason. The Board and staff feel this will improve the level of officiating necessary to remain consistent with the caliber of play. Three-person officiating has been experimented with across the state during this past regular season. Currently, more than 30 states in the nation use three-person officiating in post season play.

# ASSAILANT RECEIVES SENTENCE

Recently an individual came out of the stands to attack a KHSAA basketball official. Recent legislation has made such an act a Felony. The individual received a \$200 fine, \$76.50 in court costs, 30 day jail time suspended and probated for two years, must perform community service and write a letter of apology to the referee and the principal of the school involved.

#### **1999 STATE GOLF SITES ANNOUNCED**

Also at the March Board of Control meeting, the Board approved and announced the dates and sites for the 1999 Girls' & Boys' State Golf Tournaments. The Girls' State Golf Tournament will be played Oct. 4-6 (Oct. 4 is practice day) at Arlington Country Club in Richmond. The Boys' State Golf Tournament will be played Oct. 6-8 (Oct. 6 is practice day) at Gibson Bay Golf Course in Richmond.

# TITLE IX SEMINARS

The KHSAA, in conjunction with the Kentucky School Board Association and the Kentucky Department of Education, conducted workshops in Bowling Green and Lexington regarding Title IX compliance guidelines for interscholastic athletics.

State regulations now mandate that KHSAA member schools be in compliance with Title IX as a condition of membership. Copies of Title IX guidelines and other resource materials have been mailed to member schools.

#### DISQUALIFICATION REMINDER

Schools are reminded that contained in this year's form packet mailed in May was a new KHSAA Form GE9 to request the reinstatement of a disqualified player. It is no longer necessary to call the office to request the reinstatement if this form is properly completed unless it is a repeat or multiple game offender, or the official indicates additional investigation is necessary. Complete instructions are contained on the form.

# SLOW PITCH SOFTBALL

The 1999 KHSAA Slow Pitch Softball State Tournament will be held May 14-15 at the Rivershore Sports Complex in Hebron. The following schools have responded to the KHSAA survey that they will be fielding a slow pitch softball team this season.

#### SPRING SPORTS POSTSEASON

Several calls have been made to the office regarding Spring Sports Championships, most notably the Baseball/Fast Pitch Softball district tournaments.

As is listed on the 1998-99 KHSAA school calendars and in the Handbook, district baseball and fast pitch softball tournaments are scheduled to begin May 24. This is a week later than in the past. The change was made in March due to the Memorial Day holiday and facility availability at state venues.

The State Slow Pitch Softball Tournament will be May 14-15. The State Tennis Championships will be held June 3-5 and the State Track & Field Meet will be June 4-5. The State Fast Pitch Softball Tournament will be June 11-12 and the State Baseball Finals will be June 17-18.

Any school or group of schools that desire(s) to hold a postseason tournament earlier than the dates printed should direct a request to the Commissioner's office.

# COACHING QUALIFICATIONS REMINDER

This reminder as it relates to coaching. HB215 that passed in 1998 concerning paraprofessional transportation also impacts coaching qualifications. In addition to the present KHSAA requirements, it is also necessary that a coach (head or assistant), at any level (Grades 9-12) meet the following -

- Level 2 and 3 Coaches shall be 21 years of age, shall not be a violent offender or convicted of a sex crime as defined by KRS 17.165 which is classified as a felony, and shall submit to a criminal record check under KRS 160.380.
- (2) Level 2 Coaches shall be persons holding a provisional or standard teaching certificate or having completed sixty-four (64) semester hours of college credit from an accredited college or university as documented by an official transcript.
- (3) Level 2 and 3 coaches shall have completed all requirements for the Kentucky Coaches Education Program as detailed in Section 1(d) of this bylaw prior to being hired and prior to beginning coaching duties.
- (4) Prior to assuming duties, Level 2 and 3 coaches shall successfully complete training provided by the local school district. The training shall include, but not be limited to, information on the physical and emotional development of students of the age with whom the Level 2 and/or Level 3 coach will be working, the district's and the school's discipline policies, procedures for dealing with discipline problems, and safety and first aid training. Follow up training shall be provided annually.

#### 1999 VOLLEYBALL SEASON REMINDER

Practice for the 1999 Volleyball season can begin on July 15, 1999. The first playing date for the regular season is Aug. 16. Beginning this year, postseason will include district play. District tournaments will be double-elimination and are scheduled for the week of Oct. 10. Regional Tournaments will also be double-elimination and will be held the week of Oct. 17. The single-elimination State Tournament (regional winner and runner-up advance to State) will be held on Oct. 29-30 at Bellarmine College in Louisville.
