#### **ELECTION RESULTS**

2005-06 Board of Control election results were announced March 8. Lonnie Burgett, Superintendent of Mayfield Independent Schools, and Jeff Perkins, Director of Special Programs for the Somerset Board of Education were each elected to an additional four-year term. Mike Barren, Athletic Director of Paul Dunbar, was elected to his first four-year term.

Mr. Burgett represents Regions 1 and 2; Mr. Perkins is the African-American representative for Region 9-16; and Mr. Barren represents the Regions 11 and 12.

# **BYLAW 4 REMINDER**

A key provision of Bylaw 4 should be reiterated to all school personnel at all grade levels in KHSAA school systems at this time of year. Once a student is promoted from grade eight to grade nine by the school, the student's four year (eight semester) limit begins to toll.

Students who are "held back" after being promoted from grade eight (8) are not only ineligible for high school sports (grade 9-12) at any level during the year they repeat, but lose the "senior" year as well as the four year count would be exhausted. School personnel should be mindful of this fact when parents request such action.

State regulations clearly call for the school to have the final say in promotion and retention decisions, and once the student has been promoted from grade eight, the four year count has begun.

# MEMBER SCHOOLS REMINDED ABOUT APPROVED CHANGES IN OFFICIALS FEES

At the September 16, 2004 Board of Control Meeting unanimously approved the following motions effective for the 2005-2006 season:

- The BOC set a minimum \$40 fee for Swimming officials for regular season meets. For invitational meets or those with four or more schools entered, the fee shall be \$60 per official. The fee for officiating KHSAA Regional Swim Meets shall be \$65 plus applicable travel for officials.
- 2) The BOC established a fee for officiating a standard school day or half-day (3 hours or less) weekend Track meet which shall be a minimum of \$45 per division for the two licensed officials (Referee & Starter). For larger meets that require longer than three hours, the fee shall be \$65 per official for the two KHSAA licensed officials (Referee & Starter). If additional referees are hired at the discretion of the meet management, they shall receive the same fee. Beginning in 2005-2006, Regional Track meet assigned officials shall be paid a minimum fee of \$65 per classification. The fee for officiating a standard Cross Country meet shall be a minimum of \$30 per race for the Meet Referee, who shall be a licensed KHSAA Track and Field Official. If additional referees are hired at the discretion of meet management, they shall receive the same fee. Cross Country Regional meet assigned officials shall be paid a minimum fee of \$35 per race.
- 3) The BOC also determined that Volleyball officials shall receive a minimum of \$37.50 per match during regular season. For post season, the official shall receive \$42.50 per match during District competition (in the case where an official is required to travel outside of the local assigning area by virtue of the assignments, the fee shall be increased by \$5 per person, per contest); \$47.50 per match during Regional competition (in the case where an official is required to travel outside of the local assigning area by virtue of the assignments, the fee shall be increased by \$5 per person, per contest); and, State tournament officials shall be paid \$52.50 per contest.
