FROM THE COMMISSIONER'S DESK



Hello everyone and welcome to the beginning of the 2004-05 school year. Here's hoping your summer was fun and productive. On behalf of the entire KHSAA Staff and Board we are all looking forward to working with each of you during the upcoming year. We will be visiting with many of you during our scheduled regional meetings which are

listed on the KHSAA calendar. It has been a busy summer, with our fall sports practice in full swing and KHSAA staff already out in the state conducting rules clinics for coaches and officials.

The KHSAA Board of Control met on July 15, 2004 and the following are highlights of the meeting:

- Approved a new tennis alignment and format effective for the 2005 tennis season
- Approved Director's and Officers and General Liability insurance proposals
- Reviewed an amendment to KRS 159.035 which states "A principal shall give a student an excused absence of up to ten (10) school days to pursue an educational enhancement opportunity determined by the principal to be of significant educational value, including but not limited to participation in an educational foreign exchange program or an intensive instructional, experiential, or performance program in one (1) of the core curriculum subjects of English, science, mathematics, social studies, foreign language and the arts

A) A student receiving an excused absence under this subsection shall have the opportunity to make up school work missed and shall not have his or her class grades adversely affected for lack of class attendance or class participation due to the excused absence.

B) Educational enhancement opportunities under this subsection <u>shall not include nonacademic</u> <u>extracurricular activities</u>, but may include programs not sponsored by the school district.

The current interpretation in "B" has been clarified in that the current wording does not include extracurricular activities as "educational enhancement".

- Reported that Kentucky will be the host state for the NFHS Section II Meeting on September 26-28 in Louisville.
- Continued to study the basketball alignment further with a presentation to be made to the Board in August.

The Board of Control approved **January 13, 2005** as the date for this year's Annual Meeting. The Annual Meeting for the 2005-06 school year will be scheduled for October, 2005. The exact date will be determined later upon confirmation of the site.

KHSAA HANDBOOK UPDATES

The deadline for changes to school information for the publication of the 2004-05 KHSAA Handbook is Aug. 6.

Please make sure all information that pertains to your school (coaches' names, addresses, sports sponsors, principal's name, email addresses, phone and fax numbers) is updated and correct. Updates should be done online through the KHSAA website (www.khsaa.org) using the "Member Schools" link.

HEAT ILLNESS PREVENTION

Enclosed you will find the KMA/KHSAA Heat Illness Chart. We ask all school athletic administrators to carefully review this material and check further information available on the main page of the website http://www.khsaa.org. Please remember these guidelines are not only intended for football, but all KHSAA sports. These important reminders are critical to the safety, health and welfare for the student athlete.

TITLE IX - PRIME TIME BASKETBALL GAMES

After review of several 2003-04 boys' and girls' basketball schedules, a concern still exists regarding "prime time" playing opportunities for girls' basketball contests.

"Prime time" is defined as contests on Friday night and/or Saturday day/Saturday night and relate to home games for the contestants at the reviewed school. "Prime time" opportunities for girls' home basketball games should reflect a comparable percentage when compared to the "prime time" opportunities scheduled for boys' home basketball games. "Prime time" basketball games played away from home do not demonstrate any initiative in scheduling or hosting prime time playing opportunities, with regards to providing equitable playing opportunities for the purpose of Title IX compliance.

The KHSAA will soon begin the review of each school's scheduled 2004-05 basketball contests. KHSAA Board of Control policy requires all basketball schedules to be posted on the KHSAA website. As has been mentioned in several previous editions of these Commissioner's Notes, this review will focus on "prime time" contests schedule for both boys' and girls' games.

One hundred fifty one schools were notified in January 2004 that their 2004-05 "prime time" playing opportunities for boys' and girls' basketball must be comparable. The details of that compliance standard were spelled out in the January 2004 correspondence to those schools. For those schools failing to meet the required 2004-05 standard, the following scenario of penalties will be applied:

- 1. School A fails to meet the "prime time" standard for girls' home games. Therefore, the first boy's team contest (non-tournament) on School A's schedule involving a visiting school (School K) that also does not meet their required home "prime time" standard will be cancelled. Both opponents will suffer a forfeit (loss) without the ability to reschedule another boy's contest. No forfeit fee will be exchanged. If no visiting team on School A's boy's home schedule is themselves in violation of the "prime time" home game standard, then School A's first boy's "prime time" game (non-tournament) in February (January, if none exist in February) will be cancelled. School A will suffer a forfeit (loss) and a forfeiture fee must be paid to the visiting team suffering the elimination of the game. The visiting team, now missing a game, may reschedule another contest.
- 2. School K, which lost their away game at School A because they also failed to meet the 2004-05 requirement, will also be subject to the loss of one

of their boy's home games because they do not meet the 2004-05 requirement. In effect, School K (and schools in similar situations) could find itself as a school that would lose two boy's games (one home and one away) off of their allowable 24 regular season contest.

3. Schools seeking to appeal the penalty may be heard before the KHSAA Board of Control at their November 2004 meeting.

SANCTIONS FOR OUT OF STATE CONTESTS

KHSAA member schools hosting an event are to complete the NFHS sanction form and include a processing fee in the amount of \$75.00 if the contests includes any of the following criteria:

- 1. The event involves two or more schools which is cosponsored by or titled in the name of an organization outside the school community (e.g., a university, theme park, athletic shoe/apparel company.
- 2. Non-bordering events if five or more states are involved.
- 3. Non-bordering events if more that eight schools are involved.
- 4. Any event involving two or more schools that involves a team from a foreign country. (The exceptions to this rule are Canada and Mexico).

The fee should be made payable to the National Federation and sent to the KHSAA with the appropriate form. The KHSAA is responsible for forwarding the form and fee to the National Federation Office. When Kentucky member schools are participating in out-of-state contests, the host school from out-of-state is responsible for completing the sanction form through the applicable state association. A sanction form is not required if all participating schools are from bordering states of Kentucky. Please note, however, that Tennessee and West Virginia require a sanction form for every out-of-state event. POST SEASON VOLLEYBALL (DISTRICT TOURNAMENT)

Athletic Directors and Volleyball Coaches are again reminded that beginning with the 2004-05 Volleyball post season tournaments, all district tournament play (October 11-16, 2004) will be a single elimination tournament. The winner and runner-up from each district (single elimination) tournament will advance to the single elimination regional tournament (October 18-23, 2004). The winner of the single elimination regional tournament will advance to the sixteen (16) team State Tournament in Frankfort, KY on October 29-30, 2004.

SCHOOLS REMINDED ABOUT ENROLLMENT REQUIREMENT

Five interpretative case situations from the Handbook should serve as important guides for school administrators regarding participation by non-enrolled students. These should answer most inquiries that come from parents and coaches.

Case BL-4-11- May a student participate for a member school while enrolled **i** another school that does not offer a particular sport?

No, a student must be enrolled as a full-time student and receiving credit through the member school at which participation is desired, or be a student at a "feeder" school in the same school district.

Case BL-4-12- May a student enrolled at a private or parochial school below grade nine represent a public member school in competition in grades 9-12?

No, a student must be enrolled as a full-time student and receiving credit through the member school at which participation is desired, or be a student at a "feeder" school in the same school district.

Case BL-4-13- May a student enrolled at a private or parochial school below grade nine represent a public school in competition in grades below grade nine?

That decision would be left to the local Board of Education of the public school district and/or its related Site Based Decision Making organizations.

Case BL-4-14 – May a home-schooled student participate in interscholastic athletics at a KHSAA member school?

Unless that student is enrolled full-time (minimum four hours of instruction) at that local high school or under that local Board of Education, he/she may not participate. In order to represent a member school, a student must be a full-time student at a KHSAA member school or at a feeder school under the same local Board of Education as the member school.

Case BL-4-15 – May a home-bound student participate in interscholastic athletics at a KHSAA member school?

In order to represent a member school, a student must be a full-time student at a KHSAA member school or at a feeder school under the same local Board of Education as the member school. It should be noted that in accordance with 704 KAR 7:120, Section 2, part (6), "Eligibility for home/hospital instruction shall cease if the student works or participates in athletic activities." Schools and school districts should be mindful that a student who practices and/or plays in an athletic contest is no longer able to be in home bound instruction once such participation occurs. **Case BL-4-16** – May a student enrolled in an alternative, A6 or other type program school participate in interscholastic athletics at a KHSAA member school?

No, not unless that student is enrolled full-time (minimum four hours of instruction) at that local high school or under that local Board of Education for which they desire to participate. In order to represent a member school, a student must be a full-time student at a KHSAA member school or at a feeder school under the same local Board of Education as the member school. The A6 and other alternative-type schools are separate entities with their own unique school identification numbers and data, and as such, are considered to be outside the scope of students who can participate for another school.

TRANSFER FORM INFORMATION

July through October are some of the busiest times of the year for processing domestic and non-domestic student eligibility forms #GE06 & #GE07 (Transfer Forms). Your assistance in helping with the transfer process is greatly appreciated so we can provide you with eligibility rulings in a timely manner.

- Review the transfer form and make sure the form is filled out completely by both the sending and receiving school (Incomplete forms will be returned to the receiving school).
- Include an accurate enrollment date for the student (Postdated enrollment dates cannot be processed and will be returned to the receiving school).
- Allow one week from the date you mail the form to the KHSAA before calling the office to check on the status (School personnel will receive priority).
- Inform parents that all communications regarding a student's transfer status should be between the student's family and the school personnel (Not the KHSAA).
- If questions #13-#14 are checked "NO" (.e., student has never played in a varsity contest in any sport), the transfer form does not need to be sent to the KHSAA for processing. It should, however, be kept on file at the receiving school in the student's permanent record.

The Domestic form (GE6) is located on the website at <u>http://www.khsaa.org/forms/</u> under general forms and a clean copy is also enclosed. A revised foreign exchange form (GE7) will be forwarded to member schools electronically by August 6, and will be available on the website as well.

NFL OFFERS ASSISTANCE TO IMPROVE COMMUNITY FOOTBALL FIELDS

The NFL Youth Football Fund Grassroots Program is a partnership of the National Football League Youth Football Fund (NFL YFF), which provides funding for the program, and the Local Initiatives Support Corporation (LISC) (<u>http://www.lisc.org/</u>), which provides technical assistance and manages the program, The goal of the program is to provide nonprofit, neighborhood-based organizations with financial and technical assistance to improve the quality, safety and accessibility of local football fields.

The NFL Grassroots Program provides grants of up to \$200,000 for capital improvement projects. In order to eligible for a grant under the program, projects must be sponsored b nonprofit community-based organizations with 501(c) 3 status or by middle schools or high schools. In addition, all organizations applying for funds must be located specifically and exclusively within the NFL target markets and serve low to moderate income areas within those markets.

The deadline for applying for grants is August 30, 2004.

FALL SPORTS PHOTOS DUE

Please note team photos in the sports of volleyball, football, boys' soccer and girls' soccer are due to the Association by October 1.

Please remember the photo MUST BE AN ORIGINAL. Faxed copies, copies of photos, newspaper copies, or laser printer printouts **ARE NOT ACCEPTABLE**. You may go to the "Members Only" page on the KHSAA website and use the "Upload Photo" feature. You may also e-mail the photo provided it has been scanned at a minimum DPI of 300 and is not bitmapped. The file should be sent as an attachment and saved with a file extension of .jpg, .gif. or .tif. Failure to submit the photo may result in a fine as permitted by KHSAA Bylaw 33.

Future deadlines for other sports will be published in issues of the Commissioner's Notes and the Athlete magazine.

NEW SOCCER ALIGNMENT SEEDING PROCEDURES/SITE SELECTIONS

At the Board of Control Meeting November 19, 2003, the Board approved a recommendation that re-aligned the boys' and girls' soccer districts, regions, sub-sections and sections for the 2004 and 2005 seasons into a consolidated alignment. As a result of this Board action, all Districts are required to provide the KHSAA with a new District Tournament Site Selection and Seeding Plans. All plans must be submitted to the KHSAA prior to September 7, 2004. 1. From each of the 16 Regions, we will take four singles players and four doubles teams to <u>fill up</u> the entire 64 bracket State Tournament. There is a 64 tournament bracket for each of the Boy's Singles, Girl's Singles, Boy's Doubles and Girl's Doubles, or in other words 256 slots to be filled. In the 2004 State Tournament there were 99 byes (or unfilled slots) within these available 256 slots.

2. Since Tennis is a Team sport and the KHSAA wants to continue to recognize the Team accomplishes and concepts (and since they won the Region), Franklin County's entire Boy's Team (both of their singles players and both of their doubles teams) will advance to the 2005 State Tournament.

3. Since one of their singles players did not finish in the top four, there will have to be a playoff between #3 Slim Pecton and #4 Raul Deason to determine who is actually #3 and #4. Normally #3 and #4 are simply those two players who were beaten in the semi-finals by the #1 and #2 players and no real distinction is usually given to who is actually #3 and #4.

4. This playoff between #3 and #4 is necessary because #6 (Stan Hardwick) will move up and replace the losing player in the match between #3 and #4 so that, by virtue of Franklin County's Team success, both of Franklin County's singles players can be among the four individuals going to the State Tournament.
5. There is no need to have a playoff in Doubles because both of Franklin County's doubles teams finished in the top four.

6. This concept, in conjunction with the new 16 Region alignment, will allow approximately 175 more student athletes to participate in the KHSAA State Tennis Tournament.
