#### **NATIONAL ANTHEM SINGERS**

Any student or group of four students or less interested in singing the National Anthem at a session of either the National City/KHSAA Boys' Sweet Sixteen® or Houchens Industries/KHSAA Girls' Sweet Sixteen® Tournament, should submit a CD (a cappella) to Phyllis Sallee at the Association by February 16, 2008. The Association is particularly targeting previously underrepresented populations and prefer, to highlight currently enrolled high school students.

Those individuals selected will be notified of their assigned session prior to each of the tournaments.

#### **BYLAW 25 REMINDER ABOUT GAME COUNTING**

Each year, isolated representatives of member schools face issues in potential violation due to correctly counting the contests allowed in Bylaw 25. Subsequently, coaches, athletes or athletic programs are faced with penalty situations. These violations are preventable.

Each coach in all sports should carefully review the Bylaw 25 limitations, including the case situations following the bylaw. For example, baseball and softball coaches need to be aware that all games played in an event (regardless of format) must count as the same level for all teams (varsity, JV, freshman, etc.).

Several sports have variations in tournament counting within their rules (i.e. basketball), and a thorough knowledge of the provisions of Bylaw 25 will keep coaches and other school personnel out of trouble.

The penalty for exceeding these limits is contained in Bylaw 25. The complete text of Sections 1-6 of this Bylaw is included for your review on page 3. If violations are discovered before tournament play begins, then the penalty is the removal of a team from championship play. If detected later, the individual coach of the team and/or the member school may be penalized in accordance with Bylaw 33. This includes but is not limited to, coaching suspension from contests, probation of teams and/or member schools and a dramatic reduction in future schedules to atone for the error.

Please be sure all representatives of your sports programs are aware of the contest and scrimmage limitations.

#### **NATIONAL CITY SCHOLARSHIPS**

National City Bank will again be awarding a total of 32 scholarships in the amount of \$1,000 each, one each to a boy and girl from each of the 16 basketball regions.

The scholarships are open to athletes of all sports. The application form is posted on the KHSAA website under "Hot News". Deadline for applications is Feb. 20, 2009. Winners will be recognized at the Championship game of the National City/KHSAA Boys' State Basketball Tournament on March 21.

#### **BYLAW 25. LIMITATION OF SEASONS**

Sec. 1) General Provisions Concerning All Sports

1) Loss of School Time

No school time may be lost for travel to or from, or participation in, any regular season interscholastic athletic contest.

2) Schedule of Contests on Consecutive Days

Contests shall be scheduled so that there are not four consecutive days of competition on any Monday through Thursday period while school is in session.

3) Specific Definitions for Ending of School

For all interpretations and regulations concerning the ending of the school year, including restrictions on coaching involvement, the end of the school year shall be defined as the earlier of the last day of school or May 31.

4) Specific Penalties for Violations - Too Many Contests Any school violating provisions of this Bylaw by playing too many contests may not be eligible for state championship competition or may be otherwise penalized. For the determination to be made that the limit has been exceeded, it shall be reported in writing and received by the KHSAA prior to 12:01 a.m. (midnight) ET on the first day of the postseason tournament series as established by the KHSAA Memorandum Calendar. If detected and verified, the team exceeding the limit shall be ineligible for postseason play and may be further penalized in accordance with Bylaw 33. If the report is made after that point, the team shall be penalized in accordance with Bylaw 33 but shall remain eligible for tournament play during the current season.

5) Specific Penalties for Violations - Too Many Scrimmages Any school violating scrimmage limitations may be placed on probation, prohibited from participating in preseason scrimmages in that sport for two (2) seasons, and may be prohibited from taking part in KHSAA state championship competition or other penalties in accordance with Bylaw 33. The second violation will result in automatic suspension.

6) Involvement of Members of the Coaching Staff Out of Season

Members of the high school coaching staff (paid or unpaid) shall not be prohibited from sport specific observation and evaluation (but not coaching) of any player who has played for a grade nine (9) through grade twelve (12) team (freshman, junior varsity, varsity) from the first day of school through the last day of school provided such play is under the direct control of the same local board of education as the coach is employed and provided such play is not in conflict with other KHSAA bylaws.

#### **GOLF FIRST CONTEST DATE 2009**

This is a reminder to all administrators and golf coaches regarding the first playing date for the 2009 golf season. As many of you are scheduling for the 2009 playing season, we have received calls regarding an earlier start date. The first golf contest may take place beginning August 3, 2009 as printed in the KHSAA Event Calendar and in the corresponding dates section of the Handbook.

Last year the KHSAA Board of Control approved a three day earlier start time due to course availability with regard to the Ryder Cup. This was a one time exception with the understanding of returning to the corresponding date start of season in 2009. At its December, 2008 meeting, the Board did not approve the waiver for the 2009 start date. Any school may submit a proposal to change Bylaw 25 - Limitation of Seasons to get this put on the Annual Meeting agenda. Deadline for submission of proposals is May 1, 2009.

#### **BASKETBALL PHOTOS AND ROSTERS DUE**

Please note basketball team photos are due by February 16. In an effort to help all member schools, we ask that you enter your rosters now.

For photos, please go to the "Members Only" page on the KHSAA website and use the "Upload Photo" feature. If you experience technical problems, you may also e-mail the photo provided it has been scanned at a minimum DPI of 300 and is not bitmapped. The file should be saved with a file extension of .jpg, .gif. or .tif. Faxed copies, copies of photos, newspaper copies, or laser printer printouts ARE NOT ACCEPTABLE. **Also include the "photo ID", who's who left to right**.

Rosters are entered on the "Members Only" page using the "Enter Team Rosters" link. The roster will remain open until the first day of play in the district tournament at which time all rosters will be locked, and no additional players may be added.

## CHEERLEADING RISK MANAGEMENT FOR BASKETBALL/VOLLEYBALL

The 2008-09 NFHS Spirit Rules include the following:

Rule 2 Section 1 Article 8

Stunts must not be performed during a basketball or volleyball game when the ball is in play, including free throws in basketball and just prior to the serve in volleyball.

Rule 2 Section 1 Article 13

Spirit participants must not stand behind the free throw land extended during a basketball game.
