KHSAA BASKETBALL TICKET INFORMATION

The Association continues to accept orders for 2010 PNC Bank/KHSAA Boys' and Houchens Industries/KHSAA Girls' basketball tickets. We appreciate your support of our events and hope you will order tickets if you have not done so already.

NATIONAL ANTHEM SINGERS

Any student or group of four students or less interested in singing the National Anthem at a session of either the PNC Bank /KHSAA Boys' Sweet Sixteen® or Houchens Industries/KHSAA Girls' Sweet Sixteen® Tournament, may submit a CD (a cappella) to Phyllis Sallee at the Association by February 15, 2010. The Association is particularly targeting previously underrepresented populations and prefer, to highlight currently enrolled high school students.

The Association is also seeking any choral group (of no more than 15 students) who are interested in singing a traditional version of the National Anthem and My Old Kentucky Home at the Saturday evening Championship session of either tournament. An a cappella CD may be submitted by February 15, 2010. Due to time and other restraints versions of My Old Kentucky Home and The National Anthem cannot exceed one and a half minutes each.

Those individuals selected will be notified of their assigned session prior to each of the tournaments.

BYLAW 25 REMINDER ABOUT GAME COUNTING

Each year, isolated representatives of member schools face issues in potential violation due to incorrectly counting the contests allowed in Bylaw 25. Subsequently, coaches, athletes or athletic programs are faced with penalty situations. These violations are preventable.

Each coach in all sports should carefully review the Bylaw 25 limitations, including the case situations following the bylaw. For example, baseball and softball coaches need to be aware that all games played in an event (regardless of format) must count as the same level for all teams (varsity, JV, freshman, etc.).

Several sports have variations in tournament counting within their rules (i.e. basketball), and a thorough knowledge of the provisions of Bylaw 25 will keep coaches and other school personnel out of trouble.

The penalty for exceeding these limits is contained in Bylaw 25. The complete text of Sections 1-6 of this Bylaw is included for your review on page 3. If violations are discovered before tournament play begins, then the penalty is the removal of a team from championship play. If detected later, the individual coach of the team and/or the member school may be penalized in accordance with Bylaw 33. This includes but is not limited to, coaching suspension from contests, probation of teams and/or member schools and a dramatic reduction in future schedules to atone for the error.

Please be sure all representatives of your sports programs are aware of the contest and scrimmage limitations.

REPORTING OF SCORES

Please remember to call in the scores of contests to the KHSAA/Riherd's Scoreboard immediately following each contest. The number is **1-800-453-6882** and is toll free.

While it is a Board policy that the membership cooperate with the data collection on the scoreboard or be subject to penalty, it has been proven by the membership time and again that they desire to voluntarily cooperate with this project.

BASKETBALL SCHEDULING

Bylaw 25 addresses the method of counting basketball games against the limit. In summary, here is the rule.

Each team may count a maximum of two tournaments as one game each in a "shortcut fashion" (where each and every game doesn't have to be counted against the limit of games) provided that a school plays no more than four games in any one tournament;

Each game in any tournament beyond the limit of four games shall be counted against the limit of games;

The total game limit (including two tournament shortcuts) is 23 games. This could be 21 single games and two "shortcut" tournaments (where neither tournament has a team playing more than four games), 22 single games and one shortcut tournament (where a team doesn't play more than four in that tournament) or it could be 23 single games;

There is no limit to the number of tournaments that can be entered by a team, but only two may be counted in a "shortcut" fashion, all other contests must be counted game for game.

No member school shall play more than twenty-three (23) basketball games during the regular season. A maximum of two (2) tournaments may be included in any manner other than counting each game played against the limit of twenty-three (23) games. Any two tournaments played during the regular season may be counted as one game per tournament against the limit of twenty-three (23) provided that neither tournament necessitates the team playing more than four (4) games. Any game played over the limit of four in any one tournament shall be counted against the limit of twenty-three (23) games.

BASKETBALL PHOTOS AND ROSTERS DUE

Please note basketball team photos are due by February 15. In an effort to help all member schools, we ask that you enter your rosters now.

For photos, please go to the "Members Only" page on the KHSAA website and use the "Upload Photo" feature. **Also include the "photo ID", who's who left to right**.

Rosters are entered on the "Members Only" page using the "Enter Team Rosters" link. The roster will remain open until the first day of play in the district tournament at which time all rosters will be locked, and no additional players may be added.
