#### **FOOTBALL INSTRUCTION REMINDER**

Football coaches and administrators are reminded that this is the time of year when coaches cannot have sports specific contact with the players with the exception of the ten permitted spring practice days. Coaches holding sessions where plays or football specific drills are taught or simulated (even with different sports implements such as tennis balls) are not permitted, and coaches cannot conduct any drill that simulates those done during the practice period or the season. Coaches may be present when athletes are doing non-sports specific things (such as weight training or running), but may not instruct or evaluate, only supervise, and such can only be done on the school campus.

Coaches are also reminded of the restrictions contained in Case Situation 25-30 when individual athletes attend combines, workous, clinics or other skill testing sessions are held. Those restrictions are

- 1) No football specific equipment may be used including but not limited to, playing equipment (shoes, shoulder pads) other than a helmet for protection;
- 2) No sports specific drills can be performed if any football equipment other than the helmet, is worn;
- 3) The high school coach may be present as long as sports specific drills are not being performed and as long as the activity is of a general skill nature and contact is not involved;;
- 4) Participation on the part of the student-athlete cannot be mandatory; and
- 5) There are no restrictions on seniors who have completed their eligibility.

## RIHERDS/KHSAA SCOREBOARD NOW ON IPHONE

For nearly 15 years, high school athletics fans in Kentucky have been able to follow the result of their favorite teams through the Riherds/KHSAA scoreboard website. Now, 21st century fans can get scores on the go through their iPhone thanks to the release of the Riherds/KHSAA Mobile Scoreboard application.

The app is free to access and download. To get the app, simply go the Apple App Store and type 'KHSAA' in the search bar. The app gives the user the option of each of the scoreboard pages offered on the current web site (boys' and girls' basketball, boys' and girls' soccer, volleyball, baseball and softball).

The app also offers customized search capability to view scores by date or team. Users also are given the option of customizing how often the app updates scores, including every minute. More than 1,900 dowloads of the app have occured within the first three weeks of its release.



#### TITLE IX ONLINE PROJECT FINALIZED

Member schools will be sent electronic notification in the next couple of days about the newest online resource for KHSAA schools. WHen logged in to the member school page, schools can now take the rough numbers and data gathered for the Title IX project, and submit your annual April 15 reports. # SCHOOLS REMINDED ABOUT SCHEDULING FOR 2011-2012 IN VOLLEYBALL AND BASKETBALL

Member schools are reminded that the limitation of seasons for basketball and volleyball HAS NOT changed at this time. Though the membership has voted to change the counting requirement, the change has not yet completed the regulatory review cycle. Schools should schedule based on the 2010-2011 rule as published. If the change is approved prior to the start of play in 2011-2012, schools will have the fl exibility to add games to get to the new limit.

#### **SPORT UPDATES**

#### Baseball

We continue to advise all audiences to check the KHSAA website for information on the composite bat rule change and the most upto-date listing of approved BESR composite bats approved by the National Federation.

#### Basketball

Both Sweet 16® tournaments were successful and all of the credit goes to the great teams, coaches and fans in attendance. Early reports indicate that the districts and regions were also blessed with good crowds and those proceeds, which unlike other state associations, remain with the local schools, go a long way toward funding other non-revenue producing sports.

#### **Bowlina**

The survey for schools that plan to impliment or continue bowling for the 2011-2012 school year will be out soon. Regulations for the sport will appear in the 2011-2012 KHSAA Handbook. Please continue to check the KHSAA website for bowling information as it becomes available.

#### Tennis

The Tennis Clinic will be online from 3/4 until 3/31 for makeup only and may be viewed by coaches for the makeup fee (\$100) during this period.

#### Softball

Teams participating in the 2011 KHSAA State Softball Championships will have a format change from past years. This year the tournament has been expanded to three days, with the first eight games of the tournament taking place on Thursday night beginning at 5 p.m. This will not disrupt any travel plans

since the teams already arrived on Thursday for a pre-tournament mixer at the Owensboro Sportscenter. The two additional rounds on Thursday will allow for greater flexibility with weather delays as well as student-athlete safety.

## Swimming & Diving

The 2011 Pannell Swim Shop/KHSAA State Swimming and Diving Championships were contested at the Ralph Wright Natatorium at the University of Louisville from Feb. 24-26. This was the first year of an expanded format and the meet enjoyed record attendance and participation. The format change allowed the diving preliminaries to take place on Thursday evening and gave those student-athletes their own forum for which to perform. The changes were well-received by coaches, student-athletes and fans alike.

#### Track and Field

A reminder to schools who have pole vaulters that coaches are required to have pole vaulting coaches certification through the PVSBC (http://www.pvscb.com/). Also a reminder that pole vaulting only meets do not count toward your limitation of meets for the season. The State Championship dates, which were set and announced this past summer, are May 26-28 with one class competing each day. #### Volleyball

Coaches are continually reminded that the Bylaw change approved by the schools and KHSAA Board is still within the approval process. Athletic Directors and Coaches are advised to continue to schedule for the 2011 season under the current "old" format of 20 contests, of which 3 tournaments can in counted in the shortened manner of one contest. We will communicate to schools immediately when we have fi nal approval and the new Bylaw change goes into effect.

#### Wrestling

The KHSAA State Wrestling Championships were held Feb. 17-19 at the Frankfort Convention Center. The sport continues to grow as more than 4,200 spectators packed the arena for Saturday's championship. Union County won the team championship this season, while Ryle was the runner-up. Five additional schools sponsored the sport this year, bringing the total to 94.
