

RULES CLINICS UPDATE

Rules clinics for basketball, cheer, swimming & diving, and



wrestling have been posted on the KHSAA web site and are now open without fee. The clinics will remain open until Nov. 1. Starting on Monday, Nov. 1, clinics may be viewed with a fine through Dec. 31, 2011.

PRINCIPALS CLINIC UPDATE

The principals clinic was posted on the KHSAA website on Sept. 26 and may be viewed without a fee through Oct. 31. From Nov. 1 through Nov. 30, there will be a \$100 fine for late attendance. The fine will be waived for those paid delegates to the November KASSP Conference in Lexington. From Dec. 1 through Dec. 31, the fine will be \$300.

SPORT UPDATES

Baseball

We are still getting minimal inquiries regarding bats for the 2012 season. For the 2012 season, only all wood bats or bats stamped that they meet BBCOR standards will be legal. BESR only bats are **not** legal.

Bowling

As we continue to verify schools who will be participating, we remind schools that the regions will not be set until once the season has begun. Schools should work with the proprietors of their local bowling center to establish usage of lanes and terms of that usage. Many of the bowling centers have offered to help

with helping getting the students interested in bowling with play days and scheduling.

Cheer

We have received some clarifications from the NFHS regarding the Cheer Rules Clinic. Please forward the following on to your cheer coach. The Rules Clinic Power Point stated: Rule 2-6-4c prohibits full/single load in twists from being performed on a gym and/ or track etc...

It should have read:

Rule 2-6-4c prohibits full/single load in "released" twists from being performed on a gym and/or track etc.

Cross Country

Football school Athletic Directors and Coaches are reminded that the original deadline for roster entry has long since passed. The final deadline for roster editing and updating will be on Monday, October 31. Only those players who appear on the online roster system are eligible to appear in any contest as that is the master eligibility listing. Thanks for taking care of this important chore.

Athletic Directors,don't forget that for the boys' regional tournaments in odd numbered years (2011), the host shall be the district winner in the odd numbered district. And for the girls' regional tournaments in odd numbered years, the host shall be the district winner in the even numbered district. The KHSAA State Volleyball Tournament semifinals and final will be streamed live on khsaa.tv in partnership with iHigh.com. The Tournament is scheduled for Oct. 28-29 at Knight Hall on the campus of Bellarmine University in Louisville. Each of the 16 participating schools will have an allotment of advanced tickets to sell at a discounted price of \$8.
