

BRIEF WELCOME

Congratulations on behalf of the Kentucky High School Athletic Association Board of Control and staff for advancing to the 2021 KHSAA State Tennis Championships.

Refer to this manual and the important website links included at the end of the document to guide you through preparation for your participation.

KHSAA CONTACTS

The primary contact for tennis is Assistant Commissioner Michael Barren (mbarren@khsaa.org).

If Mr. Barren is for some reason not available, Associate Commissioner Butch Cope (<u>bcope@khsaa.org</u>) is the backup contact.

They, along with Event Management Specialist Dan White (<u>dwhite@khsaa.org</u>), will be on site throughout the event to assist you as needed.

COVID-19 GUIDANCE

BASIC COVID-19 STANDARDS

The KHSAA's complete "Healthy at Sports, Stage 3 - Performance, Return to Competition: Considerations for Spring Sports & Sport-Activities" document for tennis can be found at the following link: <u>https://bit.ly/3aVnMbX</u>

In addition to tennis specific guidance, this document includes guidance for all sports, officials and officiating, COVID-19 Medical Evaluation and Return-to-Play protocol, as well as the KHSAA's COVID-19 Return to Play Form.

The information in this document should be thoroughly reviewed by all managers, participants and spectators attending a regional tournament.

Differences in the guidance are necessitated by the differences in sports, facilities, geographic areas, and pronounced differences during normal years and magnified this school year.

Please note that many of these items are very fluid and are changing rapidly at this stage of the pandemic, therefore coaches and fans should monitor the KHSAA twitter feed (@khsaa and @khsaaevents) as well as the KHSAA Facebook page for updates.

ATTENDANCE LIMITATIONS

At all KHSAA events held prior to May 28, attendance shall be limited to 60% of capacity for venues with a seating capacity of less than 1000, and 50% of capacity for events with a seating capacity of more than 1000.

At all KHSAA events held on May 28 or later but prior to June 11, attendance shall be limited to 75% of capacity for venues with a seating capacity of less than 1000, and 60% of capacity for events with a seating capacity of more than 1000.

These seating limitations do not supersede the requirement for venues to utilize social distancing where practical and feasible in accordance with CDC guidelines.

If weather forces play indoors, there may be additional limit on attendees with varying occupancy limits based on venue requirements.

ADMISSION INTO VENUES WITH SYMPTOMS OF COVID-19

REMINDER - Any individual with symptoms of COVID-19 shall not be admitted. which include:

- Symptoms may appear 2-14 days after exposure to the virus. People with these symptoms may have COVID-19:
- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches



- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

Look for emergency warning signs for COVID-19. If someone is showing any of these signs, seek emergency medical care immediately:

- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Pale, gray, or blue-colored skin, lips, or nail beds, depending on skin tone

MASKS, FACE COVERINGS

All non-participants entering a venue before, during, and after a contest who are fully vaccinated as defined by the CDC should consider wearing a mask/face covering but it is not required.

All non-participants entering a venue before, during, and after a contest who are not fully vaccinated as defined by the CDC are required to wear a mask/face covering unless they are actively eating or drinking.

All participants entering a venue before, during, and after a contest should consider wearing a mask/face covering but it is not required.

SOCIAL DISTANCING (REQUIRED WHERE PRACTICAL AND FEASIBLE)

Social distancing should be maintained at all times, where feasible for all involved in the contests, but required for spectators at all times by sitting apart from individuals from other households, unless all are vaccinated.

CROSS-REFERENCE TO OTHER GUIDANCE

All individuals involved in the athletic program are expected to reference all guidance standards, including those in this sportsspecific guidance and the All Sports Guidance document.

If there is an ambiguity between recommended guidelines, the most stringent should apply, and deference shall be given to the KHSAA Return to Play Material as other resources amend their guidance later.

GENERAL INFORMATION

ADMINISTRATIVE AND VENUE SETUP

Everyone involved is reminded of the need to wash hands often and adopt the other principles of a good hygiene strategy. (RECOMMENDED)

Locker room and shower areas will be closed. (REQUIRED)

Avoid sharing food, drinks or towels. (REQUIRED)

Players and coaches must bring their own water bottles. (REQUIRED)

Athletes are permitted to wear gloves and/or masks/face coverings during competition with no restriction on color or type.

OFFICIATING (MECHANICS) (ADOPTED FOR 2020-21)

Officials and event management should follow all social distancing guidelines (pre- and post-event conferences, tabulations and posting of results). (REQUIRED)

Bring personal hand sanitizer and wash hands frequently. (RECOMMENDED)

Don't share equipment. (REQUIRED)

Do not shake hands and follow pre- and post-match ceremony guidelines established by state associations. (RECOMMENDED)



Officials and other meet management personnel should always wear masks / face coverings when indoors and outdoors, unless fully vaccinated. (RECOMMENDED)

When providing an explanation of a ruling to a head coach, the official will meet the coach apart from others, while practicing appropriate physical distancing. (RECOMMENDED)

OFFICIATING (RULES) (ADOPTED FOR 2020-21)

Leave the court as soon as reasonably possible. (RECOMMENDED)

Wash your hands thoroughly or use a hand sanitizer after coming off the court. (RECOMMENDED)

No extra-curricular or social activity should take place and no congregation after playing. (REQUIRED)

Eliminate pre- and post-match handshakes . (RECOMMENDED)

QUALIFYING FOR PARTICIPATION IN CHAMPIONSHIPS

The champion, runner-up and semifinalists in both the singles and doubles regional tournaments advance to fill a 64-place, single-elimination state tournament bracket, regardless of the team score results.

COMPETITION DATES, LOCATION AND SCHEDULE

DATES

The 2021 KHSAA State Tennis Championships will be held June 1-3.

Play on Tuesday, June 1 will be split between the UK Hilary J. Boone/Downing Tennis Complex in Lexington and Top Seed Tennis Club in Nicholasville.

All matches on Wednesday, June 2 and Thursday, June 3 will be played at Top Seed Tennis Club.

TICKET AVAILABILITY AND POLICIES

TICKETS

All spectators at matches on Tuesday, June 1 will need a free digital ticket via <u>khsaatickets.org</u>.

The free tickets, as well as the paid admission for later rounds, will be available online via GoFan, the KHSAA's official digital ticket vendor at https://www.uksaatickets.org.

Fans are to purchase their free tickets before they arrive and once on site, they may validate the tickets on their phones.

General admission ticket prices for Wednesday and Thursday, June 2 and 3 are \$15 each day, plus electronic transaction fees that are not received by the KHSAA.

There will be re-entry without the purchase of a new ticket, including at alternate-weather venues, via a wristband. Fans should again purchase their tickets before they arrive to facilitate entry and minimize congregation of those waiting.

There will be no paper tickets sold at the walk-up gate or cash sales. Any on-site transactions will be digital using the personal devices of the customer. No screenshots of tickets shall be honored at any time.

ALTERNATE-WEATHER VENUE ADMISSION

If weather forces play indoors, there may be additional limits on attendees with varying occupancy limits based on venue requirements.

A new ticket will not be required if play is moved indoors, however, priority on entry will be offered to the following groups:

- Families of participants actively competing at that time.
- Additional coaches of the actively competing participants.
- Administrators from the actively competing participants' schools.

PRE-EVENT LOGISTICS

CONFERENCE CALL

There will be a web conference via Zoom for participating coaches and athletic directors at 10 a.m. ET on Friday, May 28. Additional instructions regarding the call will be sent via email once the field is set.

Participants can set up from any location to join the conference and are encouraged to join by computer to view pertinent information, maps, etc.

PRE-CHAMPIONSHIP, ON-SITE MEETING

There will be no mandatory, pre-competition meeting at the venue. Instead, teams should use the conference call to ask any questions.

PRACTICE

There is no on-site practice time available at any venue.

LODGING

Schools will arrange lodging for their participants if needed and are responsible for all travel expenses, including lodging, for participation in the event.

Have your school's or Board of Education's Sales Tax Exempt Number with you at check-in to avoid sales tax from being added to the hotel bill.

A listing of hotels offering reduced rates for participants at the State Tennis Championships is included as a link at the end of these instructions.

PARKING

University of Kentucky

- Parking is located in the "R" lots, as well as the "Green" lot next to Kroger Field.
- The Green lot will also be used for bus parking.
- "E" lots are for UK employees. Cars parked there may be ticketed and/or towed.
- A University of Kentucky parking map is listed on the tennis page of the KHSAA website and is included as a link at the end of these instructions.

Top Seed Tennis Club

- Parking is very limited, please consider carpooling if possible.
- Top Seed will be providing parking attendants on site. Look for them for guidance.
- Do not park in the Bridgepointe Retirement Complex next to Top Seed.
- Bus drivers will be told to drop off students at Top Seed before being directed to an alternate site.



BYLAW 22 - REQUIREMENT TO ACCOMPANY

You are reminded that KHSAA Bylaw 22 requires a principal, coach or another approved individual of the school to be present along with any student-athlete who is representing a member school.

POSTSEASON ROSTERS AND SUBSTITUTIONS

POSTSEASON ROSTERS

Schools have previously logged into the KHSAA website and designated the postseason roster, which is separate from the regular-season varsity roster.

Roster revisions had to be made before the first date of the postseason when online rosters were closed and considered final.

Only players appearing on the school's postseason roster as of the first date of the postseason are eligible to participate in any round.

The online, postseason roster may be printed from the KHSAA website as the valid listing of available participants.

This roster information is also used for advance preparations for state qualifying teams.

SUBSTITUTIONS/LIMITATIONS

The postseason roster serves as the required eligibility listing for the team in the event of a permitted substitution.

There cannot be a substitute for a singles player at any time during the tournament.

The Tournament Manager may allow a substitution on a doubles team prior to the first match of the championship if the original entry is prevented from participating due to injury or illness.

• No advantage may be gained by the substitution, or it will not be permitted.

Once the first match of the tournament has begun, there cannot be any substitutions.

ADMISSION INTO VENUE

PARTICIPANT ENTRY

The Designated Representative from each school will be emailed GoFan ticket information for the qualifying players.

Upon arrival at player check-in, a KHSAA representative will assist the head coach in validating their participating players on either the coaches' or participants' phones.

Team members outside of the participating athletes must purchase a ticket in advance through GoFan.

TEAM PARTY ENTRY - NON-PARTICIPANTS

The player check-in gate will open at 7 a.m. ET on Tuesday, June 1 at both venues.

Players and coaches need to arrive at the venue together for admission.

The Designated Representative from each school will be emailed GoFan ticket information for up to two (2) coaches only.

Once on site, the coaches' tickets will be redeemed on their phone at either the main ticket gate or pass gate.

Do not redeem the tickets prior to arriving at the gate.

Due to attendance limits for 2021, there will be no complimentary admission given to Principals, Athletic Directors, Superintendents, bus drivers, extra coaches, managers, trainers, etc., and these individuals will need to purchase a general admission ticket through khsaatickets.org.

Coaches must be listed on the KHSAA school page and have completed all of the Bylaw 25 coaching requirements.

FAN ENTRY

Everyone must enter and exit through the admission gate, which opens 30 minutes before the start of play each day.

Children five-and-under will be admitted free, but must still "purchase" the free ticket through GoFan.

There will be re-entry without the purchase of a new ticket, including at alternate-weather venues, via a wristband.

No coaches' cards, KHSAA Administrator cards or officials' ID cards will be honored at the gate.

GoFan's training page for buying and sharing tickets is included as a link at the end of these instructions.



VENUE SAFETY

Persons who attend KHSAA events may be injured as a result of the risks inherent in being a spectator at such events.

Please advise KHSAA or venue personnel of any situation you encounter which you or a team member feels should be addressed to minimize risk to all involved.

Any crowd control problems or acts of violence should be brought to the attention of the event staff, which will contact the appropriate authorities.

Attendance at events is a vital family and community based activity which is encouraged.

VENUE LOGISTICS

DRESSING/LOCKER ROOMS

Locker room access is not provided on-site.

Participants should arrive at the venue dressed and ready to compete.

WATER - COVID-19 GUIDANCE

Coaches and athletes are reminded to bring their own water bottles and no community dispensers can be used.

Refer to the "All Sports Guidance" section of the "Healthy at Sports" document <u>(https://bit.ly/3aVnMbX)</u> for multiple references to water, hydration and food guidelines.

SIGNAGE, BALLOONS AND NOISEMAKERS

Signs/banners are permitted at the facility but must be of good taste and sportsmanship.

The signs/banners must be handheld.

The signs/banner shall not cover any corporate signage or obstruct the view of patrons.

Amplified noisemakers or items that replicate game management cues are not permitted inside the facility. These items include, but are not limited to: air horns, electronic amplifiers, portable sound systems, instruments that require additional electricity, game clock horns and whistles.

Artificial noisemakers of any kind are not permitted inside the facility per NFHS rules.

Balloons, which can block the view of other patrons, are not permitted at the event.

Only venue provided amplified music is permissible, but only during pre-match, natural and planned breaks.

WHEELCHAIR/A.D.A. ACCOMMODATIONS

The KHSAA will exercise normal care and control to provide students and fans with accessible seating.

Efforts will be made to make a reasonable accommodation for those individuals who may need wheelchair access or other needs due to disabilities.

Please see an event staff member for instructions.

CONDUCTING THE EVENT

COMPILATION OF ENTRIES

KHSAA staff along with the tournament manager will supervise the conduct of the seeding and draw in accordance with the Board of Control adopted competition rules.

BRACKETS/DRAW SHEETS

The state championships will utilize a 64-position bracket with up to 16 seeded positions based off of one (1) seed for every four (4) entrants.

Brackets will be posted in advance of the championships on the tennis page of the KHSAA website.

Printed copies of the brackets will not be provided by the KHSAA.



WITHDRAWAL OF NON-SEEDED PLAYER

Any withdrawal of a non-seeded player prior to play beginning shall result in leaving the player in the bracket and advancing the opponent by withdrawal.

ALTERNATE SITE

In case of inclement weather, play during the championships may be moved indoors.

If play is moved indoors, directions to the alternate venue will be given on-site, as well as through the KHSAA website, texting system and social-media accounts.

Attendance will be limited at the alternate sites for indoor competition.

A new ticket will not be required at the alternate venue, however, priority on entry will be offered to the following groups:

- Families of participants actively competing at that time.
- Additional coaches of the actively competing participants.
- Administrators from the actively competing participants' schools.

RULES POINTS OF EMPHASIS/CLARIFICATIONS

COMPETITION RULES

The championships shall be played using the rules as established by the USTA, unless modified by the KHSAA.

MATCH PLAY AND SCORING SYSTEM

All match play shall be best two-out-of-three sets, with the third set being a super tie-break.

INCLEMENT WEATHER SCORING

A modified scoring method may be implemented by the Tournament Director due to inclement weather per the Competition Rules.

Modified scoring may be implemented at the beginning of a round and could be "no-ad" scoring/continuous play with no break between second and third set tiebreakers.

POINT SYSTEM TO DETERMINE TEAM CHAMPIONS

Each singles player and doubles team will receive one (1) point for each match won throughout the tournament.

The school that accumulates the most points throughout the event is the state champion.

The school accumulating the second-most points throughout the tournament is the state runner-up.

TIE-BREAKING PROCEDURES FOR TEAM POINTS

In the case of a two-way tie in points for the team championship, the tie will be broken using the following method:

- The team with the highest percentage of games won during the tournament will receive first place.
 - o Example: Team A plays 200 games wins 100 = 50%; Team B plays 210 games wins 160 = 76%.
 - o Team B would be named the state champion.

If there is still a tie, it will remain and duplicate awards will be given.

REQUIRED BALL

Tennis balls will be provided for each match by the KHSAA Tournament Manager.

Wilson is the official ball used for all KHSAA State Championship play.

COURT SPECIFICATIONS

The facilities meet the proper specifications according to the USTA.

STATE EVENT OFFICIALS

Officials presiding over the event are licensed by the USTA and assigned by the KHSAA staff.



SPORTSMANSHIP

The KHSAA requires officials to enforce sportsmanship rules.

High school athletics emphasize positive values and all parties have worked hard to create a sense of teamwork, respect, responsibility and perspective.

We remind you that officials expect good behavior and will quickly penalize misconduct.

We encourage and appreciate your help in letting this competition reflect mutual respect among all participants and officials.

HEALTH INFORMATION

ATHLETIC TRAINERS

The Association will use the services of the University of Kentucky Sports Medicine Department to provide trainers for the State Tennis Championships.

Athletic Training staff will be available beginning one (1) hour prior to play and remain available throughout the day.

Any school desiring admission of its own certified trainer shall have to purchase a ticket. Please notify Mr. Barren for approval.

PHYSICAL EXAM FORM

Schools are reminded that they are responsible for ensuring parental permission to seek medical treatment is authorized for each participant.

The Principal, Athletic Director or Head Coach can use a copy of KHSAA Form GE04 (Physical Exam Form) for this purpose.

The form contains appropriate emergency treatment permission and should be brought for each athlete at the competition.

EMERGENCY ACTION PLAN

KHSAA staff will, in consultation with the athletic training staff and venue personnel, develop an Emergency Action Plan (EAP) for this event and the plan will be available upon arrival from the athletic training staff.

If an athlete or fan is in need of emergency medical attention, contact the nearest KHSAA staff member, official, UK Sports Medicine trainer or venue staff so emergency medical services can be reached.

An AED will be located at the team check-in area.

INCLEMENT WEATHER PROCEDURES

In the event of inclement weather, it is the duty of the KHSAA, in consultation with the host facility, to make decisions in regard to postponement, rescheduling or cancelation, including getting proper notification to all teams, media outlets and schools.

Staff will utilize the KHSAA website and Twitter to provide updates as well as an emergency text notification system.

KHSAA officials will make every effort to learn the weather forecast prior to the start of competition as the safety of the public and participants will be the most important factor in any decision.

VIDEOTAPING, MEDIA AND INTELLECTUAL PROPERTY RIGHTS

GENERAL MEDIA RIGHTS

At all levels of competition during postseason play, control of media access and location at those contests is with the KHSAA, and as such, there are necessary policies and restrictions concerning this event and these provisions will be vigorously enforced.

The intellectual property, corporate, broadcasting and media rights to all postseason rounds belong exclusively to the KHSAA, including titling agreements and sponsorships.

Control of media access and location at all levels of postseason play is with the KHSAA.

At all levels of KHSAA sponsored postseason events, including district, regional, semi-state, quarterfinal and state competition, allowances shall be made for television media to record video of the contests, without play by play, at no charge as long as the sole purpose is for newscast highlights.

At all levels of KHSAA sponsored postseason events, including district, regional, semi-state, quarterfinal and state competition, allowances shall be made for other media outlets to be admitted to the contests as long as the sole purpose is for reporting of the actions taking place at the contest and promoting the event.



Participating teams in KHSAA events shall be allowed to record the contest, for coaching purposes only, if space is available with such availability at the discretion of the KHSAA and may be required to sign a waiver indicating that the KHSAA shall be held blameless for any and all liability to those parties involved in the video recording.

Any video recording must not violate existing, acknowledged, written copyright protection or intellectual property agreements and cannot be broadcast in any form, including internet and social media.

If space is deemed available, the KHSAA has the right to designate a specific area for video recording and no video recording will be allowed outside of that area.

The determination of space availability is solely with the KHSAA and shall be equitable for all teams.

Freelance/commercial photographers, as defined herein, will not be granted access to KHSAA events unless the requisite media rights fee is paid.

A commercial photographer is any person, including a school employee, who will capture images from the event and re-sell them to anyone, including team members, the families or the general public.

SCHOOL MEDIA CREDENTIALS

Due to restrictions on attendance based on COVID-19 capacity limits, school media credentials will not be issued for KHSAA Spring Championships.

TRADITIONAL MEDIA CREDENTIALS

Traditional media members (print, TV, radio, online) interested in covering KHSAA State Championship events should apply for credentials through the KHSAA's online system. A link to the credential application is included at the end of these instructions.

The deadline to apply is Monday, May 31 at 5 p.m. ET.

Applications should be submitted by the editor or director at each organization.

Complete information should be submitted for all attendees (including unique email addresses and cell phone numbers), as the KHSAA will use these methods to communicate information surrounding the event.

Due to COVID-19 attendance restrictions, media outlets will be limited to three (3) credentials.

Freelance/commercial photographers, as defined herein, will not be granted access to KHSAA events unless the requisite media rights fee is paid.

Media members will follow all local/state/federal requirements when it comes to PPE, health screening, physical distancing, capacity, etc.

Media members will wear a mask at all times, including broadcasters, unless fully vaccinated.

TEAM BROADCASTS

By paying the requisite fee, each school qualifying for a KHSAA State Championship event may designate one (1) radio station or website to originate an AUDIO-only broadcast of each match its affiliated school participates in.

An official representative of the participating school shall designate to the KHSAA which station/website will be permitted to broadcast its game using SI113 (School Audio Broadcast Designation Form).

The radio station/website shall then apply for championship credentials through the KHSAA's online credentialing system.

Originating stations/websites will be subject to a media rights fee, which will be outlined through the online credentialing system.

MEDIA RIGHTS FEE

Freelance/commercial photographers as defined in these instructions and radio stations interested in originating a broadcast of a KHSAA State Championship event are subject to a media rights fee.

Information regarding the fee for each event is available through the online credentialing system.

TELECAST/WEBCAST INCLUDING NFHS NETWORK RESTRICTIONS

The KHSAA is a full member of the NFHS Network and as such, restrictions exist on all postseason levels.

A telecast, as used in these instructions, is a video, live or delayed account, including play by play, of any contest over the air.



A webcast, as used in these instructions, is a video, live or delayed account, including play by play, of any contest distributed using the internet.

The KHSAA is the only entity permitted to produce live or delayed video from state championship events including semi-state, quarterfinal and state rounds, and is the sole authority for approval of any other.

No entity, unless given prior approval by the KHSAA shall be permitted to produce video telecasts or broadcasts, with the exception of approved media outlets solely recording highlights for news use.

No entity, including media members, may stream live video content during postseason events including the use of social media products such as Facebook® Live.

The mandated minimum fee schedule will be published annually by the Commissioner's office on the KHSAA website.

For all postseason play, all questions regarding live or delayed broadcast or telecast policies, including requests for approval shall be referred to the Communications Director for approval by the Commissioner.

MUSIC COPYRIGHT

KHSAA schools are reminded to adhere to all music copyright laws.

FILMING

External power sources may not be used by patrons.

Spectators may film with a hand-held camera from the spectator area, but may not in any manner transmit live video through any resource, including personal social media accounts.

Violators are subject to removal.

EVENT MERCHANDISE

KHSAA State Championship apparel will be available for sale at the event and online at the following link - <u>bit.ly/3bRT7g4</u>.

TeamIP is the exclusive vendor of championship apparel.

No outside merchandise representative of the event may be produced by any other entity and sold or distributed at the championship venue.

The distribution of trophies and medals for deserving teams will be discussed during the conference call on Friday, May 28.

- Individual medals will be given to the semifinalists and quarterfinalists for singles and doubles

OFFICIAL KHSAA CHAMPIONSHIP PHOTOS

Official championship photos of the event will be available for purchase through the KHSAA's online photo gallery within 72 hours of the completion of the event.

Non-credentialed photographers must take all photos from the confines of the spectator areas.

FINANCES AND EXPENSES

There is no school reimbursement for this event.



Member schools are responsible for all expenses incurred for participation.

The KHSAA underwrites the expenses of facility rental, security, first aid, judges and event workers.
