


# **GENERAL WINTER INSTRUCTIONS FOR ALL SPORT AND SPORT ACTIVITIES**

# **SUPERSEDURE NOTE**

The information in these instructions supersedes any information previously distributed, including the Competition Rules.

In many cases, these rules have been revised over the last couple of years through the pandemic to the point where time has not permitted complete overhaul and revision of the competition rules

All involved should review items such as tiebreakers and procedures for competition and consider this document authoritative.

Contact the primary event contact with any additional questions.

# WATER

Coaches and athletes are reminded to bring their own water bottles as no community dispensers can be used.

# **VENUE SAFETY**

Persons who attend KHSAA events may be injured as a result of the risks inherent in being a spectator at such events.

Please advise KHSAA or venue personnel of any situation you encounter which you or a fellow spectator feels should be addressed to minimize risk to all involved.

Any crowd control problems or acts of violence should be brought to the attention of the event staff, which will contact the appropriate authorities.

Attendance at events is a vital family and community based activity which is encouraged.

# SIGNAGE, BALLOONS, NOISEMAKERS AND MUSIC

Signs/banners are permitted at the facility but must be of good taste and sportsmanship.

The signs/banners must be handheld or attached in a manner not to damage the existing structure.

The signs/banner shall not cover any corporate signage or obstruct the view of patrons.

Amplified noisemakers or items that replicate competition management cues are not permitted to include, but not be limited to:

- Air horns that may interrupt cadence or cause safety issues in specific sports and sport-activities
- Electronic amplifiers
- Portable sound systems unless used by bands during outdoor events when they are permitted to be used by playing or competition rules
- Whistles
- Game clock horns simulator

Managers should confiscate items if used with the managers determining if they are returned post championship.

Balloons, which can block the view of other patrons, are not permitted at the event.

Only venue provided amplified music is permissible, but only during pre-event, natural and planned breaks/timeouts.

# **ENTRY OF SERVICE ANIMALS**

Service animals are important and valued professionals that serve the needs of owners and must be present at all times.

Because service animals are essential for specific individuals, we wanted to make all attendees are aware of the definitions and guidelines in place to make certain service animals are present as well as to ensure the well-being of all individuals in attendance at KHSAA championship events.

Service animals are the only animals the general public may bring into the indoor and outdoor facilities of a KHSAA championship.

The Americans with Disabilities Act (ADA) defines a service animal as a dog who has been trained to perform a task directly related to an individual's disability.

Upon entry to a championship, owners of service dogs may be asked questions as recommended by the ADA to ensure the owner access to their service animal.

The training a service animal receives distinguishes it from other animals and there may be questinos about the training provided

to the animal and service provided.

Emotional support animals, therapy animals, and other pets are not considered service animals and will not be granted entry to KHSAA events.

In Kentucky, misrepresentation of an assistance animal is a violation with a fine up to \$1000.

The owner will be responsible at all times for the conduct of the service animal.

Thank you for respecting the training and necessity of service dogs and helping us keep all quests safe when visiting a KHSAA championship event.

# **SPORTSMANSHIP**

The KHSAA requires officials to enforce sportsmanship rules.

High school athletics emphasize positive values and all parties have worked hard to create a sense of teamwork, respect, responsibility and perspective.

We remind you that officials expect good behavior and will guickly penalize misconduct.

We encourage and appreciate your help in letting this competition reflect mutual respect among all participants and officials.

# **ROSTERS**

# POSTSEASON ROSTER

Postseason participants must be designated from the freshmen, junior varsity or varsity rosters, which are maintained through the KHSAA member school website throughout the regular season.

Roster revisions must be made before the first date of the postseason when online rosters are closed and considered final.

No additional players may be added to the roster following that deadline, including those teams that advance to the state tournament.

The online, postseason roster may be printed from the KHSAA website as the valid listing of available participants.

This roster information is also used for advance preparations for state qualifying teams or individuals.

# **BYLAW 22 REMINDER**

# REQUIREMENT TO ACCOMPANY TEAM MEMBERS

You are reminded that KHSAA Bylaw 22 requires a principal, coach or another approved individual of the school to be present along with any student-athlete who is representing a member school.

# **HEALTH INFORMATION**

# PHYSICAL EXAM FORM

Schools are reminded that they are responsible for ensuring parental permission to seek medical treatment is authorized for each participant.

The Principal, Athletic Director or Head Coach can use a copy of KHSAA Form GE04 (Physical Exam Form) for this purpose.

The form contains appropriate emergency treatment permission and should be brought for each athlete at the competition.

# **EMERGENCY ACTION PLAN**

UK HealthCare Sports Medicine is the official Sports Medicine Partner for the KHSAA State Championships.

KHSAA staff will, in consultation with UK HealthCare Sports Medicine and venue personnel, develop an Emergency Action Plan (EAP) for this event.

An AED (and in many events, multiple AEDs) will be on site for use in the event of an emergency, including specific assignments to the designated on-site training staff.

The on-site training staff will also be responsible for any necessary monitoring of the wet bulb globe temperature and notification to KHSAA staff and the contest officials for determinations of any necessary adjustment to activity.

If an athlete or other team member is in need of emergency medical attention, contact the nearest KHSAA staff member, official, trainer or venue staff so emergency medical services can be immediately contacted.

An AED will also be located at the team check-in area.

# **ATHLETIC TRAINERS**

The Association will use the services of UK HealthCare to provide trainers for the KHSAA state events, and in the event of disagreement, this group shall serve as the primary determinant of medical next steps.

Athletic Training Staff will be available beginning one (1) hour prior to the event and remain available throughout the day. For team sports - basketball, baseball, field hockey, football, soccer, softball, and volleyball - individual school Athletic Trainers should be included in the distribution of Team Party passes.

For other sport and sport activities, see the sport-specific section of these instructions for bringing a team trainer.

# **INCLEMENT WEATHER PROCEDURES**

In the event of inclement weather, it is the duty of the KHSAA, in consultation with the host facility, to make decisions in regards to postponement, rescheduling or cancelation, including getting proper notification to all teams, media outlets and schools.

Staff will utilize the KHSAA website and Twitter to provide updates as well as an emergency text notification system.

KHSAA officials will make every effort to learn the weather forecast prior to the start of competition as the safety of the public and participants will be the most important factor in any decision.

# **HEAT INDEX PROGRAM**

Tournament play will adhere to the KHSAA's Heat Index Program, which pertains to the outside temperature as well as monitoring the indoor temperature of venues without air conditioning.

Tournament administration will be responsible for tracking and implementing the program's guidelines.

Should the heat index reach 95 degrees, mandatory 10-minute water breaks will be given every 30 minutes.

At 99 degrees, play shall stop, and the heat index will be monitored every 30 minutes.

# LIGHTNING/THUNDER POLICY

The District or Region Manager of any outdoor sports or activities, or indoor sports with non-grounded pools, working with the certified athletic trainer and facility staff, shall monitor and adhere to the KHSAA Board adopted policy in regard to lightning and thunder.

All competitions shall be suspended at the first sound of thunder or sight of lightning and shall be suspended a minimum of 30 minutes following any subsequent sound/sighting.

Remember per the US Weather Bureau, Heat Lighting does not exist, it is a myth.

Lightning is lightning if it can be seen or heard, period.

If it is anticipated that the storm will pass, competition may resume following a 15-minute warm-up period.

The detailed medical policies are online and a link at the end of this general section.

# **VIDEOTAPING, MEDIA AND INTELLECTUAL PROPERTY RIGHTS**

# **GENERAL MEDIA RIGHTS**

At all levels of competition during postseason play, control of media access and location at those contests is with the KHSAA, and as such, there are necessary policies and restrictions concerning this event and these provisions will be vigorously enforced.

The intellectual property, corporate, broadcasting and media rights to all postseason rounds belong exclusively to the KHSAA, including titling agreements and sponsorships.

Control of media access and location at all levels of postseason play is with the KHSAA.

At all levels of KHSAA sponsored postseason events, including district, regional, first round, second round, guarterfinal and state competition, allowances shall be made for television media to record video of the contests, without play-by-play, at no charge as long as the sole purpose is for newscast highlights.

At all levels of KHSAA sponsored postseason events, including district, regional, first round, second round, guarterfinal and state competition, allowances shall be made for other media outlets to be admitted to the contests as long as the sole purpose is for reporting of the actions taking place at the contest and promoting the event.

Participating teams in KHSAA events shall be allowed to record the contest, for coaching purposes only, if space is available with such availability at the discretion of the KHSAA and may be required to sign a waiver indicating that the KHSAA shall be held blameless for any and all liability to those parties involved in the video recording.

Any video recording must not violate existing, acknowledged, written copyright protection or intellectual property agreements and cannot be broadcast in any form, including internet and social media.

If space is deemed available, the KHSAA has the right to designate a specific area for video recording and no video recording will be allowed outside of that area.

The determination of space availability is solely with the KHSAA and shall be equitable for all teams.

A freelance/commercial photographer is any person, including a school employee, not representing an established media outlet or a person who will capture images from the event.

# **SCHOOL MEDIA CREDENTIALS**

Each school is permitted one (1) school media pass at KHSAA State Championship events, valid only for a student or full-time school employee, for the sole purpose of reporting the events for school internal publications.

Space permitting, school media may be granted floor photography access consistent with traditional media acess.

Outside entities such as professional photographers, videographers or parents may not utilize the school media pass.

The school media pass may not be used for taking pictures that will later be sold as these individuals need to apply for a freelance/commercial photographer pass and pay the requisite fee.

This pass must be requested in advance of the start of the event through the online credentialing system linked at the end of these instructions.

# TRADITIONAL MEDIA CREDENTIALS

Traditional media members (print, TV, radio, online) interested in covering KHSAA State Championship events should apply for credentials through the KHSAA's online system. A link to the credential application is included at the end of these instructions.

The deadline to apply is 3 p.m. the day before competition begins.

Applications should be submitted by the editor or director at each organization.

Complete information should be submitted for all attendees (including unique email addresses and cell phone numbers), as the KHSAA will use these methods to communicate information surrounding the event.

Media outlets may be limited during this event.

Freelance/commercial photographers, as defined herein, will not be granted access to KHSAA events unless the requisite media rights fee is paid.

# **MEDIA RIGHTS FEE**

Freelance/commercial photographers as defined in these instuctions and radio stations interested in originating a broadcast of a KHSAA State Championship event are subject to a media rights fee.

Information regarding the fee for each event is available through the online credentialing system.

# TELECAST/WEBCAST INCLUDING NFHS NETWORK RESTRICTIONS

The KHSAA is a full member of the NFHS Network and as such, restrictions exist on all postseason levels.

A telecast, as used in these instructions, is a video, live or delayed account, including play-by-play, of any contest over the air.

A webcast, as used in these instructions, is a video, live or delayed account, including play-by-play, of any contest distributed using the internet.

The KHSAA is the only entity permitted to produce live or delayed video from state championship events including first round,

second round, quarterfinal and state rounds, and is the sole authority for approval of any other.

No entity, unless given prior approval by the KHSAA shall be permitted to produce video telecasts or broadcasts, with the exception of approved media outlets solely recording highlights for news use.

No entity, including media members, may stream live video content during postseason events including the use of social media products such as Facebook® Live.

The mandated minimum fee schedule will be published annually by the Commissioner's office on the KHSAA website.

For all postseason play, all questions regarding live or delayed broadcast or telecast policies, including requests for approval shall be referred to the Media Relations and Publications Director for approval by the Commissioner.

#### MUSIC COPYRIGHT

KHSAA schools are reminded to adhere to all music copyright laws.

# **FILMING**

External power sources may not be used by patrons.

Spectators may film with a hand-held camera from the spectator area, but may not in any manner transmit live video through any resource, including personal social media accounts.

Violators are subject to removal.

# **EVENT MERCHANDISE**

KHSAA State Championship apparel will be available for sale at the event and online at the following link - khsaa.teamip.com.

KHSAA State Championship apparel will be available for sale at the event and online post event via the TeamIP link on all pages of the KHSAA website.

TeamIP is the exclusive vendor of championship apparel, please look for their tent at the championship event to purchase memorabilia.

No outside merchandise representative of the event may be produced by any other entity and sold or distributed inside the playing facility.

# **OFFICIAL KHSAA CHAMPIONSHIP PHOTOS**

The KHSAA pays for professional photography coverage of the event.

Official championship photos will be available for purchase through the KHSAA's online photo gallery within 72 hours of the completion of the event, khsaaphotos.org.

# QUALIFYING FOR PARTICIPATION AT STATE FINAL ROUNDS

# **BOYS'/COED COMPETITION**

The top four (4) wrestlers in each weight class shall advance from the region to their drawn slot in the Feb. 15-16 Wrestling State Championships at Alltech Arena at the Kentucky Horse Park.

- Any female who participated on a boys'/coed team at a region tournament shall only compete in the boys'/coed state event.
- Females competing in the boys'/coed division will not be eligible for individual awards in the girls' competition.

# **GIRLS' COMPETITION**

The top four (4) wrestlers in each weight class shall advance from the two-region combination regional to their drawn slot in the Feb. 17 Wrestling State Championships at Alltech Arena at the Kentucky Horse Park.

The 2024 KHSAA Wrestling State Championships presented by UK HealthCare will be held Feb. 15-17 at Alltech Arena inside Kentucky Horse Park.

# **TICKET AVAILABILITY, NON PARTICIPANT ENTRY AND POLICIES**

# **PURCHASING TICKETS**

All state championship tickets will be sold exclusively online via GoFan, the KHSAA's official digital ticket vendor, at khsaatickets. orq.

Digital ticketing enhances convenience and safety for all fans, while providing flexibility and safeguarding against counterfeit tickets.

Schools already utilizing GoFan will have their school "tagged" as soon as the semifinals are over to help with the ticketing

Fans are encouraged to purchase their tickets before they arrive to help ensure a smooth entry.

There will be no paper tickets sold or cash sales at the walk-up gate.

GoFan's training page for buying and transferring the tickets is included as a link at the end of these instructions.

Ticket holders will access their tickets on their phones and can transfer them electronically to other members in their party when necessary.

Spectators are strongly encouraged to download the GoFan mobile app and save the tickets through that app prior to arrival.

Tickets can be purchased via credit card at the admission gates to the site.

No tickets will be sold from the box office or on site using cash.

# **FAN ENTRY**

All non-squad members (individuals other than the properly qualified coaches and participants) must enter and exit through the admission gate which opens at 8:30 a.m. ET on Thursday and Friday, and at 9 a.m. on Saturday.

Any charges for parking will be included in the ticket fee.

# **TICKET PRICING AND CONFIGURATION**

The price for one day will be \$20, all fees included, if purchased prior to midnight on day of the event.

The price increases to \$24, all fees included, after midnight on day of the event.

Purchasers will be issued a wristband to be visibly worn all day to allow for re-entry to the facility.

The price for two days of competition will be \$36, all fees included, if purchase prior to midnight on day of the event.

The price increases to \$40, all fees included, after midnight on day of the event.

Purchasers will be issued a wristband to be visibly worn both days to allow for re-entry to the facility.

The price for all three days will be \$50, all fees included, if purchased prior to midnight day of the event.

The price increase to \$60, all fees included, if purchased after midnight day of the event.

Purchasers will be issued a wristband to be visibly worn all three days to allow for re-entry to the facility.

Kentucky Children's Hospital is sponsoring FREE tickets for all children 10-and-under.

- To receive these qualifying free tickets, you must "purchase" them through khsaatickets.org even though there will be no charge.
- Purchasers will be issued a wristband to be visibly worn all day to allow for re-entry to the facility.

Kentucky Horse Park will charge a \$4 parking fee, which is included in the ticket price, of which, KHP retains the entire fee.

# **COMPLIMENTARY PASSES AND ENTRY**

Only the KHSAA issued Commonwealth Card will be honored for admission for one individual plus a guest for the Superintendent, Principal and Athletic Director of each participating school.

No coaches' association cards or KHSAA officials' ID cards will be honored at any gate.

Any individual not in uniform as a participant or holding a Team Party credential will be required to have a ticket for admittance.

No passes, other than those produced by the Association for the championships, will be honored at the pass gate.

Examples of passes NOT accepted include, principal passes and cards (other than the Commonwealth Card and only for the participating teams), coach passes and cards, athletic director passes, official passes and any other type of identification.

# PRE-EVENT AND SITE LOGISTICS

#### **CONFERENCE CALL**

There will be a brief web conference for participating coaches and athletic directors at 2 p.m. ET on Tuesday, Feb. 13.



Additional instructions regarding the call will be sent via email once the field is set.

Participants can set up from any location to join the conference and are encouraged to join by computer to view pertinent information, maps, etc.

There will be no mandatory, pre-tournament meeting at the venue.

# **PRACTICE**

There will be no opportunity for on-site practice time individually or as a team.

# LODGING

Schools will arrange lodging for their contestants if needed and are responsible for all travel expenses, including lodging, for participation in the event.

Have your school's or Board of Education's Sales Tax Exempt Number with you at check-in to avoid sales tax from being added to the hotel bill.

A listing of hotels with rooms being held for the Wrestling State Championships, including rates, is included as a link at the end of these instructions.

# **PARKING**

There is ample on-site general parking.

Kentucky Horse Park will charge a \$4 parking fee, which is included in the ticket price, of which, KHP retains the entire fee.

Buses dropping off participants will unload them on the south side of Alltech Arena (Alltech Way).

Spaces will be blocked off to allow buses to drop off participants.

After buses unload, they will proceed to the main parking lot in front of the arena and park in its lower section.

The bus driver can then enter through the pass gate at the participant entrance (Alltech Way) free of charge.

# **TEAM AND PARTICIPANT ADMISSION INTO VENUE**

# **PARTICIPANT ENTRY**

Upon arrival at team check-in, a KHSAA representative will assist the head coach in validating their participating wrestlers.

Team members outside of the participating wrestlers must purchase a ticket in advance through GoFan for entry.

# **TEAM PARTY ENTRY-NON PARTICIPANTS**

Gates will open for coaches and wrestlers ONLY at 7 a.m. Thursday, 7:30 a.m. Friday and 8 a.m. Saturday. Those not competing in the event or on the coaching list will not be admitted until the arena opens for the general public.

This includes regional fifth-place finishers who are alternates that must also weigh in to be admitted at no charge.

Coaches packets may be picked up at the participant entrance of Alltech Arena starting at 7 a.m. ET on Thursday and 8 a.m. Saturday. Each packet will contain commemorative bag tags for the participants.

Packets will also contain admission credentials for coaches listed on the school's personnel database on the KHSAA website who meet all Bylaw 25 requirements.

Coaches must be current in the KHSAA/KMA Sports Safety Course, be current in the rules clinic for 2023-24 and be current in CPR certification to be issued a coaches' pass.

This coaching hang tag must be worn at all times, including when desiring to be mat side.

Lost coaches tags will be replaced for \$24, \$40 or \$60 dependant upon at what point in the tournament it is lost.

All team members and coaches should arrive at the venue together for admission.

Admission for other individuals, including non-competing wrestlers, additional staff or others will require paid admission through khsaatickets.org.

A limit of two (2) individuals may be present in the corner and no additional persons will be allowed in the corners.

Coaches' credentials are not media credentials and do not provide access to take photos or video.

# **VENUE LOGISTICS**

# TEAM COOLERS

Teams may bring a single cooler into the facility only through the team gate to be kept in the auxiliary area adjacent to the competition arena near team check-in.

Individual coolers for fans are not permitted.

Athletes may bring in their equipment bags, but due to safety concerns, they are subject to being searched.

Any equipment bags and all gear must remain with the athlete at all times.

#### **BEDDING**

Air mattresses or other forms of "bed rolls" will not be permitted inside Alltech Arena.

# DRESSING/LOCKER ROOMS

One locker room is provided on site that does not have shower facilities.

Participants should arrive at the venue dressed and ready to compete.

# **CONDUCTING THE EVENT**

# **MATS**

Mats for the Wrestling State Championsips presented by UK HealthCare will be provided by EZ Flex and member schools. The KWOA is also providing the championship mat it purchased in collaboration with the KHSAA.

# SUBSTITUTIONS/ROLL-UPS

Should a school have a wrestler finish in 1st through 4th place in the regional tournament and they are unable to compete at the state tournament due to schedule conflicts, injury or other documented reason, school representatives shall notify the KHSAA by noon ET on Wednesday, February 14.

Failure to send proper notification of such a withdrawal will result in a penalty against the school in accordance with KHSAA Bylaw 27.

In the case of an athlete being unable to enter and being replaced, the remainder of the bracket will be "rolled-up," and the replacement wrestler will be seeded fourth.

If a vacated bracket position is unable to be filled by an alternate from the same regional tournament, the option will roll in random order to another regional tournament.

The random order will be determined and announced by the KHSAA and posted on its website.

Coaches are advised to weigh-in any 5th-place regional tournament finisher in case of replacement the day of the state tournament.

# STATE COMPETITION OFFICIALS

Officials presiding over the event are licensed and assigned by the KHSAA.

# **GROWTH ALLOWANCES/WEIGH-INS FOR 2024**

In 2024, for the boys'/coed competition, a ONE-POUND growth allowance will be added to the weight classes for day two qualifiers.

In 2024, for the girls' competition, there will be no growth allowance.

Official weigh-ins are set to begin at 8 a.m. ET on Thursday and Friday, 9 a.m. on Saturday at Alltech Arena.

Make sure your travel plans allow for timely arrival as NFHS rules state that all athletes must be prepared to weigh-in at the scheduled time.

In accordance with the competition rules and NFHS playing rules, the scale will close for each weight class when the first competitor of the succeeding class weighs in.

The scale will close immediately after the last 285-pound wrestler weighs in.

At approximately 9:15 a.m. on Thursday, wrestlers will assemble in the staging area for the Parade of Champions.

At approximately 9:40 a.m. on Saturday, wrestlers will assemble in the staging area for the Parade of Champions.

Complete instructions for the parade will be provided to coaches prior to the event.

# **DRAW**

# **BOYS'/COED DRAW**

For the Boys'/Coed Wrestling State Championships, per the competition rules, the Commissioner shall draw each weight class individually for the pairings at the state tournament.

The base draws will be posted on the KHSAA website on Monday, February 10.

The format will be a blind draw with the 1st-place finisher from each regional tournament drawing a 4th-place finisher from another regional tournament.

These regional tournament champions will not be paired with a 4th-place competitor from their own regional tournament in an opening match or be placed in the same bracket with the runner-up from their regional tournament.

The 2nd-place competitors cannot draw a 3rd-place finisher from their own regional tournament.

As soon as possible and practical, the state tournament entries will be posted on the KHSAA website.

For the state finals, the sequence of matches will be drawn that morning.

# **GIRLS' DRAW**

For Girls' Wrestling State Championships, brackets will be a random draw table wherein the number four (4) wrestler from one regional tournament will be paired against the number one (1) wrestler from another region tournament and the number two (2) wrestler from one region tournament will be paired against the number three (3) wrestler from another region tournament.

A random draw will be conducted to pair the regions using the table below, where the draw will specify which region in each weight class represents regions A, B, C and D as listed below.

- Region A 1st Place vs. Region B 4th Place
- Region D 2nd Place vs. Region C 3rd Place
- Region B 1st Place vs. Region A 4th Place
- Region C 2nd Place vs. Region D 3rd Place
- Region D 1st Place vs. Region C 4th Place
- Region B 2nd Place vs. Region A 3rd Place
- Region C 1st Place vs. Region D 4th Place
- Region A 2nd Place vs. Region B 3rd Place

Regions A, B, C, D will be assigned randomly for each weight class.

Final Random Draw will be published following Region Tournament completion.

# **RULES POINTS OF EMPHASIS/CLARIFICATIONS**

# **COMPETITION RULES**

National Federation (NFHS) competition rules will be utilized without exception.

For the 2023-24 season, NFHS accepted an experimental "12+1" proposal from the KHSAA that will allow us to conduct the girls' competition with the Federation's 12 girls' weight classes, while adding an experimental 285-lb. class.

This will allow the Association to remain in compliance with our Bylaw 22, which mandates that competitions comply with NFHS

The experiment was only approved for one year and will be evaluated based on continued data review following the 2024 season.

# **POINT PENALTY**

For the purpose of Rule 8-1-5 and 8-1-6 dealing with unsportsmsnalike conduct, any member of the officiating staff for the event, whether or not involved in a current match, may apply these provisions to a participating wrestler or coach. The Assistant Commissioner responsible for wrestling shall also have the ability to, as a tournament official, apply the provisions and penalties of 8-1-5 and 8-1-6 based on the actions of a coach.

# HEALTH INFORMATION

# ATHLETIC TRAINERS

The Association will use the services of UK HealthCare to provide trainers for the KHSAA state events.

Teams are permitted to bring their own trainer given this information is provided prior to the state championship event to UK HealthCare's Jenne DeAngelis.

# **SKIN CHECKS**

The KHSAA will provide medical staff to make skin checks during weigh-ins.

If needed, please have an updated KHSAA Form WR111 (Skin Condition Form) available for their review. A link to that form is included at the end of these instructions.

# **RESULTS**

Results will be available through the wrestling page of the KHSAA website, with updated brackets to be posted as well.

KHSAA staff will make every effort to keep results posted on the video board in the end zone.

In addition, updated scoring will be available via KHSAA.org and TrackWrestling.

# **TROPHIES AND AWARDS**

Trophies and awards will be given to the top four (4) teams and top eight (8) individuals in each weight class.

Wrestlers should stay in the awards area immediately following the conclusion of their medal bout in order to participate in the awards presentation.

# **AWARDS PRESENTATIONS**

- Participation in the awards ceremony is NOT optional and is an expectation when entering the tournament.
- Coaches, Athletic Directors and others are not permitted to use cameras or camera phones to take pictures during the awards presentation.
- Only credentialed media members are permitted to take pictures during the ceremony.

After all awards are completed and venue tear down has begun, credentialed participants and coaches from the top four (4) teams may take additional celebratory pictures.

# **FINANCES AND EXPENSES**

There is no school reimbursement for this event and member schools are responsible for all expenses incurred for participation.

The KHSAA underwrites the expenses of facility rental, security, first aid, officials and event workers.
