Board of Control Meeting - February 10, 1951

The Board of Control of the Kentucky High School Athletic Association met at the Phoenix Hotel, Lexington, on Saturday morning, February 10, 1951. The meeting was called to order by President Lyman V. Ginger at 10:15, with all Board members and Commissioner Theo. A. Sanford present.

William E. Kingsolver moved, seconded by C. H. Arnett, that the reading of the minutes of the December 27th Board meeting be waived, since all members of the Board had received copies of these minutes. The motion was carried unanimously.

The Commissioner reported that Directors James L. Cobb and Carlos Oakley had been nominated for re-election to represent Sections 2 and 5 respectively, and that no other nominations had been received by January 31, the deadline for the filing of nominations, nor had any been received since that time. T. K. Stone moved, seconded by Carl Hicks, that James L. Cobb and Carlos Oakley be declared elected to Board membership for a four-year period, beginning July 1, 1951 and ending June 30, 1955. The motion was carried unanimously.

James L. Cobb, chairman of the retirement fund committee, reported that his committee had done extensive work in preparing material to be submitted to the Board of Control relative to setting up a retirement fund, but that the report was not complete and would be given to the Board at a later meeting.

James L. Cobb reported that he had been asked by the Commissioner to investigate the Corinth High School, based on a protest filed by Principal William T. McGraw of Williamstown, but that the bad weather had prevented him going into the Corinth area. He stated that the investigation would be made very soon.

Commissioner Sanford was asked to retire for a few minutes while the Board discussed the renewal of his contract. T. K. Stone moved, seconded by Carl Hicks, that Theo. A. Sanford be re-elected Commissioner of the K. H. S. A. A. for a four-year period, beginning July 1, 1951 and ending June 30, 1955. The motion was carried unanimously. Carlos Oakley moved, seconded by James L. Cobb, that the annual salary of the Commissioner for the 1951-1955 period be set at \$8000.00. The motion was carried unanimously.

Upon returning to the meeting, the Commissioner reported that, in line with previous action taken by the Board, he had applied for Social Security coverage on behalf of

Association employees, and that the Federal Government had accepted the application.

C. H. Arnett reported that he had been asked by Coach Edd Kellow of St. Mary's Academy, Paducah, to bring to the attention of the Board of Control certain problems in the Paducah area brought about when students of the Catholic faith moved into the Paducah area but did not live in the city of Paducah. Coach Kellow had requested an interpretation of the residence rule which would allow these students to be eligible at St. Mary's, even though their parents are residents of McCracken County outside of the city of Paducah. The Board discussed the problem mentioned, but declined to change its interpretation of A-B-C cases, which had been established by the Board several years ago and which in the great majority of cases has been satisfactory.

The Commissioner reported a controversy between the Minerva and Nicholas County high schools, concerning which team had been the winner of a basketball game, played at Minerva on the evening of January 19. The officials had signed the home book, which would indicate that Minerva had won the basketball game by a score of 65-64. Since the scoreboard showed Nicholas County the winner, spectators had left the gymnasium thinking that this team had won the game. Officials Edmund LeForge and Bill Harrell later considered supporting evidence, consisting of a playback of a tape recording made of the game by a Nicholas County student, and declared that Boyd of Nicholas County should have been credited with two points which were not shown on the home scorebook. The officials then declared Nicholas County the winner by a score of 66-65. It was the opinion of all members of the Board that the decision of the officials, right or wrong, must prevail.

A hearing of the Mt. Vernon case was then held by the Commissioner, with all Board members present. Representing Mt. Vernon were Supt. Clyde Linville, Prin. William G. Landrum and Coach Albright. During and following the Mt. Vernon -Liberty basketball game, played at Liberty on the evening of January 26, a Mt. Vernon player, Paul Carter, conducted himself in an unsportsmanlike manner by objecting to the officiating and cursing the official. Following the game, he and a Mt. Vernon fan, Kenneth Cummings, approached official Laurence McGhee, apparently to make trouble. McGhee slapped or struck Paul Carter, at which time the official was struck by Cummings. Cummings was arrested and taken to court. The Commissioner read all correspondence in the case, some of which indicated that Coach Albright might have been partially responsible for the trouble which developed because of certain objections which he was alleged to have made concerning the officiating. Coach Albright admitted that he had discussed one or two decisions with the official, but stated that he had not been angry at the time, and further stated that a part of the discussion took place in the dressing room with no one else present. The Commissioner stated that he had suspended Paul Carter for the remainder of the current school year, and that he had thought that a suspension of the Mt. Vernon High School would be in order since at least three representatives of the school might be guilty of violating K. H. S. A. A. By-Law 17. Supt. Linville stated that there was a second incident, not mentioned by Mr. McGhee in his letter, to which he wished to call the Board's attention, namely, that after Cummings had been taken away he (Mr. Linville) was talking to Paul Carter, scolding him for his unsportsmanlike conduct, at which time the boy denied cursing the official. He stated that Mr. McGhee, being nearby, apparently overheard the boy's denial, and had to be restrained from striking Paul Carter again. This testimony was confirmed by Coach Albright, who was also present at the time. The Mt. Vernon officials were asked to withdraw while a decision was made on the case. The Commissioner stated that, in line with the new evidence presented, it was his opinion that his ruling should be that the Mt. Vernon High School be placed on probation for the remainder of the school year for the violation of By-Law 17 by Paul Carter and Kenneth Cummings, that Paul Carter should continue to be under suspension, and that Official McGhee should be reprimanded for slapping or striking a high school player. All members of the Board of Control concurred in this decision, and the Mt. Vernon representatives were notified accordingly.

The Commissioner reported that preliminary arrangements have been made for the annual business meeting of the Association, to be held at 2:00 P.M., Friday, April 13, at the Henry Clay Hotel, Louisville, with the dinner meeting to be held at 6:00 P.M. on the same day. There was a discussion concerning the speaker or speakers for the dinner meeting. It was the opinion of the Board members that Coach Paul Bryant of the University of Kentucky should be asked to speak at the meeting, and those members who attended the Mobile meeting suggested that Phil N. Eskew of Wabash, Indiana, an outstanding speaker on the program of the National Federation annual meeting, also be asked to speak at the meeting. T. K. Stone moved, seconded by C. H. Arnett, that Messrs. Bryant and Eskew be asked to speak at the annual dinner meeting of the Association. The motion was carried unanimously.

The Board approved the giving of the usual two passes to the Louisville Courier-Journal for the Pick-The-Sixteen contest.

The Commissioner announced the regional tournament sites, being assisted in the final selection of two or three sites by Board members living in the areas involved.

The Commissioner presented certain recommendations of the State Swimming Committee, given in a letter written by E. W. Craik, a member of the committee. Roy G. Eversole moved, seconded by William E. Kingsolver, that the recommendations of the State Swimming Committee be accepted. The motion was carried unanimously.

The Commissioner announced that the State Track Meet would be held in Lexington on May 18, with the regional meets being held on Friday or Saturday, one week earlier. He stated that dates of other meets in spring sports would be announced later, authority to determine these dates having been given to the Commissioner in the meeting of December 27, 1950.

It was suggested that five golf regions be set up for 1951, tentative sites and managers being: Bowling Green, H. B. Gray; Louisville, Charlton Hummel or Russell Garth; Erlanger, Rev. Ciangetti of St. Henry; Lexington, H. L. Davis; Hazard, Roy G. Eversole.

The Commissioner presented certain recommendations made several months ago by Board member William E. Kingsolver relative to the 1951 State High School Golf Tournament. T. K. Stone moved, seconded by James L. Cobb, that the recommendations presented be accepted by the Board, and that the expenses of team and singles winners in the proposed regional tournaments be paid to the State Golf Tournament on the same basis as the allowance now made for State Track Meet participants. The motion was carried unanimously.

There was considerable discussion concerning setting up regions for tennis. The Commissioner was authorized to secure recommendations from Roger Klein, who has managed the State Tennis Tournament for several years, concerning proposed regional tournaments in tennis, and to present these recommendations to the Board at a subsequent meeting.

The Commissioner reported on the Louisville Male - Silver Creek incident, in which Coach Saylor of the Silver Creek High School (Indiana) had apparently conducted himself in an unsportsmanlike manner toward K. H. S. A. A. Official Bill Montgomery during and following a basketball game played at Louisville on January 9. The Commissioner stated that he had been advised by Commissioner Phillips of Indiana that Coach Saylor had been directed to write appropriate letters of apology to Referee Montgomery and the principal of the Male High School.

The Commissioner stated that on February 15 or soon thereafter it would be necessary for him to suspend some fifty or seventy-five K. H. S. A. A. basketball officials for failure to attend clinics. Roy G. Eversole moved, seconded by C. H. Arnett, that

a fine of \$5.00 be assessed by the Board of Control for each official failing to attend a clinic, this fine to be collected either this year or at the time when the official seeks to renew his membership in the Officials' Division of the Association. The motion was carried unanimously.

The Commissioner reported that a few schools continued to use non-registered officials. Carlos Oakley moved, seconded by James L. Cobb, that a warning be issued to these schools, and that a fine of \$5.00 be levied against each member school for the use of each non-registered official, this policy to take effect at the beginning of the 1951-52 school year. The motion was carried unanimously.

C. H. Arnett moved, seconded by Carl Hicks, that all bills of the Association for the period beginning December 27, 1950 and ending February 9, 1951, be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as the Board of Directors of the K. H. S. S. S. Protection Fund.

Roy G. Eversole moved, seconded by William E. Kingsolver, that the following claims against the K. H. S. A. A. Protection Fund be allowed:
