Board of Control Meeting -- February 13, 1954

The Board of Control of the Kentucky High School Athletic Association met at the Phoenix Hotel, Lexington, on Saturday morning, February 13, 1954.

The meeting was called to order by President Carlos Oakley at 10:15, with all Board members, Commissioner Theo. A. Sanford, and Assistant Commissioner J. B. Mansfield present.

W. B. Jones moved, seconded by Jack Dawson, that the reading of the minutes of the October meeting of the Board be waived, since all members had received copies of these minutes. The motion was carried unanimously.

The Commissioner reported that there had been ties in district tournament balloting in Districts 23 and 40, and that these ties had been broken by the President and the Commissioner in favor of Fort Knox and Paris respectively on the basis of gymnasium facilities. W. B. Jones moved, seconded by Roy G. Eversole, that the action of the President and Commissioner in breaking the District 23 and District 40 ties be approved. The motion was carried unanimously.

The Commissioner, following instructions given him in the meeting of October 3, stated that the First National Bank and Trust Company of Henderson had agreed to extend the Kentucky High School Athletic Association Annuity Trust Fund agreement to include Assistant Commissioner J. B. Mansfield, and he read a letter from Secretary N. O. Kimbler of the Teachers Retirement System, stating that an annuity of \$1,040.00 based on Mr. Mansfield's age of 38, would require annual deposits by the Association and Mr. Mansfield of \$329.20. The Commissioner then read a copy of the proposed contract with Mr. Mansfield, providing that he pay annually into the K. H. S. A. A. Annuity Trust Fund 3% of his salary, the annual base salary on which this per cent is taken not to exceed \$4800.00. Roy G. Eversole moved, seconded by James L. Cobb, that the contract with Mr. Mansfield as presented by the Commissioner be accepted; that the President and Secretary of the Board be authorized to execute the contract with Assistant Commissioner Joe B. Mansfield and to set up the trust fund agreement with the First National Bank and Trust Company of Henderson; and to make copies of the contract and trust fund agreement a part of the minutes. The motion was carried unanimously.

The Commissioner reported that, with the advice of President Oakley, he had withdrawn the registration card of Elvis Hall, a basketball official of McHenry,

Kentucky. Mr. Hall had recently been convicted in court on charges of malicious cutting, and had received a penitentiary sentence of two years. W. B. Jones moved, seconded by Roy G. Eversole, that the action of the President and Commissioner in suspending Elvis Hall from the Officials' Division of the K.H.S.A.A. be approved. The motion was carried unanimously.

Chairman Jack Dawson reported on the meeting of the State Swimming Committee, which had been held in Louisville on January 16. He discussed the various recommendations of the committee, which had appeared in the February issue of the ATHLETE. William E. Kingsolver moved, seconded by W. B. Jones, that the recommendations of the State Swimming Committee for the 1954 State Swimming Meet be adopted. The motion was carried unanimously.

The Commissioner was instructed to invite Coach Blanton Collier of the University of Kentucky to be the principal speaker at the forthcoming annual dinner meeting of the K. H. S. A. A., to be held in Louisville on April 23.

Roy G. Eversole moved, seconded by Jack Dawson, that the State Track Meet be held at Lexington on May 14-15, and that the Commissioner be authorized to set the other dates and sites of the various spring meets. The motion was carried unanimously.

W. B. Jones moved, seconded by James L. Cobb, that the fees for regional tournament officials be the same as those of last year, namely: \$20.00 per game, a transportation allowance of 7¢ per mile for all necessary travel, and a maximum lodging allowance of \$10.00 for each night of lodging if the official remains at the site of the tournament because of the distance involved in his travel, in such an event only one round trip for mileage to be allowed; and that an exception be made for Region 7 which will have only four teams in the regional, a maximum of \$100.00 and expenses to be allowed each official in Region 7. The motion was carried unanimously.

Russell Williamson moved, seconded by Louis Litchfield, that Louisville be named the site of the 1954 State Tennis Tournament. The motion was carried unanimously.

The Commissioner brought the case of Dale Moore of Inez to the attention of the Board. Dale Moore, who had been a first team competitor at the Warfield High School, had transferred to the Inez High School about the middle of January, a week or two after his father, recently elected Sheriff of the county, had moved to Inez. The Commissioner stated that the boy was currently ineligible at Inez under the provisions of K. H. S. A. A. By-Law 8, Section 1, and that he had declined to set the penalty aside and declare the boy eligible at Inez because of the objections of Principal Oran Hinkle of Warfield. The Commissioner stated that Mr. Williamson was taking an appeal to the Board from his decision, and that he had no objection to such an appeal. He was asked if any evidence had been presented to indicate that any undue influence had been used in connection with the transfer of Dale Moore from Warfield to Inez, and the Commissioner answered in the negative. W. B. Jones moved, seconded by Roy G. Eversole, that the Board of Control, acting under authority given in Article IV, Section 3-d-8, declare Dale Moore eligible for athletic competition at the Inez High School. All voted "Aye" on the motion except Russell Williamson, who did not vote.

There was a discussion on the advisability of moving the State Office of the K. H. S. A. A. to a more central location in the state. After a general discussion of the merits of the case and of the various problems involved in the move, James L. Cobb moved, seconded by Jack Dawson, that the office of the Commissioner be moved to Lexington between July 1 and September 1, 1954, and that a committee of the Board be appointed to rent, buy, or in the most economical and satisfactory manner determine and establish the new location of the office.

The motion was carried unanimously.

President Oakley named a committee composed of Chairman James L. Cobb, W. B. Jones and Jack Dawson to make the necessary arrangements for the moving of the Commissioner's office to Lexington.

W. B. Jones moved, seconded by Roy G. Eversole, that all bills of the Association for the period beginning October 3, 1953, and ending February 12, 1954, be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as the Board of Directors of the K. H. S. A. A. Protection Fund.

Secretary-Treasurer Sanford read a letter from Attorney L. Allen Rhoads of Henderson, to the effect that the Pike County court, after a pre-trial conference held on November 20, 1953, had entered an order of dismissal of the Bobby Edward McCoy (Belfry) suit vs. the K. H. S. A. A. Protection Fund. Mr. Rhoads stated that the case was now closed, and that the plaintiff, Bobby E. McCoy, is precluded from maintaining further action against the K. H. S. A. A.

The Secretary-Treasurer presented a list of claims which had been paid since October 3, 1953, the total amount of these claims being \$9,950.57. W. B. Jones moved, seconded by Russell Williamson, that the claims as presented by the Secretary-Treasurer of the Protection Fund be allowed, and that a list of these claims be made a part of the minutes of the meeting. The motion was carried unanimously. The claims are as follows:


